

## **STATEMENT OF RESPONSIBILITY**

Texas Teenage Baseball and Softball reserves the right to refuse any application or suspend or revoke any current rights granted when determined by the State Board of Directors that it is not in the best interest of the State Association.

It is the intent of TTAB-TTAS to provide participants with appropriate leadership and role models. As such, it is recommended that the local affiliates and league boards use their best judgment in allowing individuals to participate in the program. Specific areas of concern include, but may not be limited to, the individual's criminal history, the use of profane language, alcohol, illegal drugs or tobacco in the presence of the children. Any affiliate not willing to accept the above responsibility or review should not participate in TTAB-TTAS and should not submit an Application of Affiliation.

Any manager, coach, league official, or tournament director while participating in TTAB-TTAS sponsored programs:

1. drinks or allows the drinking of alcoholic beverages;
2. uses or allows the use of illegal drugs, controlled substances, or is under the influence thereof;
3. uses abusive or profane language;
4. or makes any attempt to commit or does bodily harm to any player, manager, coach, director, representative or umpire of TTAB-TTAS, shall be suspended immediately from further participation in any TTAB-TTAS sponsored activity for any number of years up to a lifetime ban to be determined by the State Board of Directors

Any fan or parent of a player participating in TTAB-TTAS guilty of any of the above infractions will be reported to their local league president for disciplinary action. Any affiliate failing to take action will be subject to suspension from further participation in TTAB-TTAS.

The State Board of Directors will review all reported infractions. Its ruling shall be considered final and shall not be subject to appeal and/or legal action. Any affiliate not willing to accept the above as a part of its local responsibility to participate in the TTAB-TTAS organization should not submit an Application for Affiliation.

The State Board reserves the right to suspend any manager, coach, league official or tournament director immediately from any TTAB-TTAS activity for any length of time. This disciplinary action shall be at the discretion of the Board and its Directors. Their decision shall be final and not subject to any appeal or legal action. TTA strongly urges all affiliates to know their volunteers and their backgrounds well. Ultimately, the safety and well being of the children is the responsibility of the local Affiliates.

## **DUTIES OF STATE DIRECTORS**

State Directors shall enforce the rules and regulations, as well as those policies issued by Texas Teenage Baseball-Softball. Such enforcement shall be by virtue of, and through the authority given each Director by the State President. It shall be the State Director's duty to preside over all Association matters within the area for which he/she is duly appointed and elected, and said Director's decisions shall take precedence over any other person, affiliate, manager, coach, league official, tournament director (whether it be in a district or state tournament), or member of the Association, so long as said decisions are related to the rules, regulations and/or policies of the Association.

State Directors shall be the highest ruling authority in their respective areas, subject only to the President and/or Vice-President of the Association. At any time a State Director sees or knows of a violation of the rules, regulations, or policies of the Association, he shall immediately take the necessary steps to correct same, with all the power and authority given him/her herein.

All actions, decisions, and rulings of State Directors shall be in the best interest of TTAB-TTAS.

State Directors are expected to be impartial toward any affiliate or team and, therefore, may not be directly involved with any team, including coaching or managing. State Directors may not participate in any TTA game or act as a tournament director or umpire.

## **ASSOCIATE DIRECTORS**

State Directors may appoint Associate Directors who can oversee a specific region of a Director's district. The Associate Director can be of general service to local affiliates, but shall take no official action regarding TTA rules and policies.

## OFFICIAL REGULATIONS

### DEFINITIONS:

For clarity, TTA defines the following terms:

Association: A term to mean the entire TTA organization.

Affiliate: A registered affiliate association member with TTA, including all towns and teams registered under said affiliation member

Affiliate Town: A town playing under an affiliate membership.

Team: A team registered and playing under an Affiliate Town.

League: Example: T-Ball, 12u Open Base, 8u Coach Pitch.

Divisions: When a league reaches 8 or more teams and has to split into multiple divisions (Example) North Division, South Division)

Manager: Head Coach

### A. ORGANIZATION

1. TTA recommends all Affiliates to perform a background check on all coaches/volunteers that will be on the field.
2. All affiliate rules and bylaws should be in writing and issued to all managers and coaches.
3. The affiliate town shall be the smallest unit of the organization and shall be affiliated with the TTA State Office each year.
4. The affiliate town shall be governed by a Board of Directors, Committee, or Association with elected officers serving as voluntary operating personnel, including a President who is the highest ruling authority of the affiliate.
5. The Board of Directors, Committee, or Association may organize and operate one or more leagues in any and all divisions of TTAB and TTAS. Each league, so organized, shall be considered a separate and independent organization within itself.

6. A League must consist of at least four (4) teams and no more than seven (7) teams, except by special permission of the State Director serving the affiliate requesting the waiver. Each league shall participate in assigned TTA District and State Tournaments. For exception, refer to Tournament Rule 200-2
7. Any affiliate registering a fictitious team for the purpose of forming a league can be subject to a penalty of up to a one-year suspension from TTA participation.
8. An affiliate may be organized of a town, city, community or county. In locations where it is warranted, a larger territory may be organized, subject to approval of the local State Director.
9. Affiliate League sign up beginning and ending dates must be approved by Area State Director.

**B. LEAGUE SCHEDULE**

1. Playing a minimum of ten (10) official league games per team shall constitute a completed league schedule. Exception to this rule will require approval from the are State Director.
2. The beginning of league play is at the discretion of local affiliates.
3. All TTAB (Baseball) league play will terminate as follows:  
     The 2026 Season on June 12.  
     The 2027 Season on June 11.
- All TTAS (Softball) league play will terminate as follows:  
     The 2026 Season on June 5.  
     The 2027 Season on June 4.
4. The official league schedule shall be prepared no later than one (1) week before the start of the regular season play.
5. The schedule shall be arranged so that no team will be required to play on successive days except for a makeup or rainout game.
6. A Calendar Week is defined as Sunday through Saturday.
7. Any league that has not finished its season by the official end of the TTA season and determined its champions shall not be eligible to participate in tournament play.

**C. POSTPONED, RAIN-OUT, AND SUSPENDED GAMES**

1. No regular scheduled games may be postponed without the approval of the Local Affiliate President.
2. It shall be the responsibility of the Local Affiliate President to see that all postponed games, rain-out or makeup games, and suspended games are re-scheduled and played at the earliest possible date. All such games must be played during the regular season of play and before the end of the Official League Season.

- (a) A postponed and/or makeup game is defined as one that is re-scheduled to be played in its entirety at a later date.
- (b) A rainout game (if less than the required complete innings have been played) is defined as a suspended game.
- (c) A suspended game is defined as one that is re-scheduled to be continued in play from the exact point of suspension of the original game. A game called by the umpire that is not a regulation game, will be resumed at the exact spot where it was stopped. All recorded stats will carry over to the continuation of the suspended game as they were upon suspension, including pitch counts.
- (d) **Pitch Counts in a suspended game:**
  - Pitch counts recorded up to the point of suspension will carry over to the continuation.
  - Any pitcher that is over the limit when the game is suspended will go into days rest at the end of the calendar day and will not be available until the applicable rest period has been completed. If a pitcher is in days rest when the continuation of the suspended game is resumed, that pitcher will not be allowed to pitch and must be removed from the mound prior to throwing a pitch. If a pitcher is in days rest from a different game when the suspended game is resumed, same would apply. Days rest shall not be waived.
  - If the pitcher is available to continue pitching in the continuation of the suspended game, the total number of pitches from the suspended portion of the game will carry over, so if the pitcher had 45 pitches before suspension, the first pitch would be #46. The total pitches applicable for the day are still in effect for that game.
  - Since a pitcher would have already served days rest for what pitches were thrown in the suspended portion of the game, if they were over 35 pitches, that pitcher will only serve days rest for what pitches were actually thrown in the continuation of the suspended game. So if a 10U pitcher had 36 pitches in the suspended portion and served one day rest the following day, the continuation was played 2 days later and that same pitcher threw the rest of the 75 pitches allowed for the day which would be another 39 pitches, that pitcher would serve one day rest the next day for the 39 pitches thrown in the continuation since he already served one day rest for the 36 pitches he threw 2 days earlier.

#### **D. LEAGUE CHAMPIONS**

1. Local league champions shall be determined by the method adopted by the local affiliate officials and the eligible teams will advance to tournament play.
2. The method used may vary according to local situations. The method used should be determined before the local league season begins.
3. Each League with 4 to 7 teams must send first and second place teams, and in some cases, third place teams at the State Director discretion (or replacement or alternate teams). Each League with 3 teams (**must have area State Director approval**) must send the first place team (or replacement or alternate team). These teams are required to participate in its assigned tournament. Penalty for non-participation can be up to a one-year suspension from TTA for that particular league and/or manager. The affiliate will also receive a non-participation fine.

#### **E. ESTABLISHING LEAGUE BOUNDARY LINES**

- (a) TTA boundary lines will be as follows:
  - School district boundary of the place of residence or
  - Where the player attends school.
- (b) If a new affiliation in TTA contains players who are a part of a team in a nearby affiliate, such players are allowed to remain on the current team through the duration of the TTA age division the player is so registered. Once such players move into a new age division, they must sign up based on the boundary line rules listed above.
- (c) Any boundary line controversy that cannot be resolved locally should be submitted to the State Director and provide complete detail.
- (d) All boundary line protests shall be settled before the TTA end of season dates. No TTA tournament will allow protests over boundary line issues.
- (e) A player must sign up and play in the designated boundary line area of which he/she lives (school district boundary of the place of residence) or where the player attends school, as long as a team or league is offered in the players age division.
  - Players that are home schooled and do not attend public school shall fall under school district boundary of the place of residence.
  - In some cases, a player's residence can be in a different school district than where they attend school, in this case a player may sign up in either location. Once a player has started an age division in their desired location, they shall finish out the current age division before changing locations.

- For all players that meet at least one TTA boundary line requirements that must go through the affiliate placement process, and is required to play in another affiliate town due to placement and has met all the requirements necessary to play in his local boundary the following year, he or she can return to the original affiliate town the following year, or choose to finish out the current age division on the current roster. Once a player ages out of an age division, they must return to their original TTA affiliate town for signups.
  - For all players that do not meet at least one TTA boundary line requirements, must go through the affiliate placement process. Once placed on a roster by the committee, that player will have the option to remain on that current roster to finish out an age division, only if the placement need is not needed for another roster needing players based on the criteria set forth in (f) **Player Placement Process**. The Placement Committee and/or the area State Director have the authority to place such players that do not meet any TTA boundary requirements back into the player placement pool if the need is there for player placement. Once a placement player has aged out of an age division, that player(s) will go back through the player placement process the following year.
- (f) **Player Placement Process** – Any players that do not have a place to play: This would pertain to players signed up past the roster limit, players from an adjacent town that need placement or players from a non-TTA town. All such players will fall under the following steps for placement.
- All affiliates will be required to form a placement committee that will have equal representation from all affiliate towns within their affiliate association.
  - All players must sign up in the town they are supposed to legally play for, based on school attended or school district of the place of residence.
  - All players that sign up from a non TTA town may turn in their form to any town within the closest TTA affiliate boundary from their place of residence, within reason factoring in distance with State Director approval. Such forms from non TTA players must be turned into the Process Committee for placement.
  - Forms from such players described above in (f) shall be kept separate from all other sign up forms until the end of signups.
  - Placement signup forms will be turned into the placement committee, following sign ups ending for roster placement.

- All sign up numbers from all affiliate towns will need to be collected by the committee prior to placement.
- Placement criteria will be reviewed on the following:
  1. Need of the player
  2. Distance
- The committee will look at roster numbers from all towns within their affiliate area and determine which rosters need additional players first and within reason according to driving distance.
- Prior to notifying parents of placement, the committee will need to discuss placement results with their area State Director. The committee will need to present the list of players and the placement criteria in writing for approval following discussion to their State Director.
- Once player placement has been determined, any player or parent refusing to play will be ineligible to play for any team.

**Any player that misses the sign up window or any player that signs up in the wrong location may be ruled as ineligible.**

**Any deviations from the boundary rules listed will require State Director approval.**

#### **F. LEAGUE PLAYER SIGN UP PROCESS**

1. All Affiliates will be required to collect the following information on their signup forms for the purpose of determining the proper location for all players based on **E. ESTABLISHING LEAGUE BOUNDARY LINES**
  - a. School district of the place of residence.
  - b. Where the player attends school.

2. Player first serve basis. All sign up forms need to be received by an authorized person on or during league approved sign up dates, once the sign up dates are posted, under no circumstance can an affiliate or town close or end sign ups early. The player sign up forms will need to be numbered in order with a date and time recorded when the form is received by local league officials, or if online signups are utilized, a time and date the form was submitted and received online. The manager/head coach's son(s) or daughter(s) signup form(s) will be pulled out of the sign up order due to being already on the team as a protected player, per TTA rule. All other players, including protected and returning players will need to go through the signup process and rules pertaining to the signup process to be considered a legal player.
3. If more than 15 sign up in a division, but not enough for 2 teams, and all options have been exhausted for making a second team and players must be released because of no room on the roster, the first 14 players that are signed up in order will be on the team, plus the protected manager/head coach's son(s) or daughter(s) to make 15. Players that are signed up past 15 in this scenario must be released, starting with #16, and shall not be protected or considered returning players. The same rules would apply if too many players signed up for multiple teams, the numbers for release would be in groups of 15, so if 31 sign up, the 31<sup>st</sup> player would be released, if 46 signed up, 46<sup>th</sup> would be released, and so on. Players that must be released based on sign up order must be released prior to the open draft and shall not be protected or considered returning players on a team roster. If two or more managers/head coaches were selected by the local board in anticipation of multiple teams being formed and the sign up numbers don't allow for what was expected on team numbers, the son(s) or daughter(s) belonging to the manager/head coach selected for the teams that will not form will be inserted into the front of the signup order and be available to be chosen as a protected player, return to a team roster as a returning player or enter the open draft, where applicable. Any player that must be released based on sign up order may be offered the opportunity to play on another team from the closest affiliate town in the same age division or offered to move up a division within their affiliate town.

**Per TTA rule, local leagues can elect to start releasing players at 13, if this is utilized, the group of 15 listed above would be 13 or 14, whichever your local league has voted in place, must be adopted and recorded in the town or affiliate local by-laws. Also note that the grouping number would also change when enough players sign up to form multiple teams.**

4. No team may roster more than 8 players of the oldest age in an age division. If more than 8 of the oldest age allowed in an age division sign up, and only one team is formed, the first 8 of the older age players in the sign up order will be on the team, released players would state at #9 in the sign up order, and so on, if there are not enough sign up for 2 teams. Same would go for 2 or more teams, calculated in groups of 8, so the first 16 signed up in order for two teams, first 24 for 3 teams, and so on. Any signed up past the group of 8 calculation would be released based on sign up order.
5. Returning roster players and protected players are not guaranteed placement on a roster and must go through a league approved and fairly administered sign up process to retain their status as a returning or protected player. The sign up process and sign up order takes precedence over protected or returning status. The only player guaranteed a roster position is the manager/head coach's son(s) or daughter(s), since by TTA rule, it is mandatory that such players must be included as protected players once a manager/head coach is determined prior to the player draft. **Any deviations or special accommodations shall be submitted to the area TTA State Director for ruling order prior to being initiated.**

#### **G. SELECTION OF PROTECTED PLAYERS**

1. The selection of players for teams will be accomplished based on the following guidelines.
2. The managers/head coach(s) must be determined prior to each age division player draft. If no person signs up to coach prior to the draft, the local board may appoint someone to draft for the team with the coach vacancy. Once a manager/head coach has been selected for a roster, that manager/head coach must remain with the current roster for the remainder of the age division (unless removed or no longer coaches a team). Once a manager/head coach has been found/selected, follow guidelines outlined below.

3. If the manager/head coach has a son or daughter playing on the team, it is mandatory that such players must be included as protected players. In the case of where the manager/head coach has multiple sons or daughters playing in the same age division, it is mandatory that all such players must be included as protected players.
  - Some leagues have sibling rules in place where if you select a player that has a sibling playing in the same age division, when you pick one, the other is automatically on the team as well. If this is in place in your local league rules, and a coach selects a sibling as a protected player, the automatic sibling pick will be listed on the roster prior to the open draft and be counted in the total number of players. If siblings are signed up in the same age division, and one or both siblings are signed up outside of the maximum roster number allowed, such player(s) will not be an automatic pick and will fall under **E. League Player Sign up Process rule #2** and will face release, placement on another team or offered to move up to the next division.
4. Protected player shall be selected by the local boards appointed team manager/head coach(s) prior to the open draft starting. It will be a requirement that the parent or legal guardian of any player selected as a protected player sign a protected player agreement noting their approval for the son(s) or daughter(s) to be listed as a protected player on the roster for the team manager/head coach. Once the protected player agreement is signed by the parent or legal guardian, the player(s) will be protected to that team roster until the protected player(s) move out of the current age division.  
**(See downloads at [texasteenage.org](http://texasteenage.org) for official protected player agreement form)**
5. No team will be allowed to have more than a maximum of 3 protected players. Protected players will be tied to the team roster (not the coach) and will remain protected so long as the same team roster exists in the same age division. A rostered player may only be returned to the open draft if a protected player spot must be vacated for a different manager/head coach's son(s) or daughter(s) to be protected. Must have the approval of the area State Director and the local board. Protected players that lose their protected player status by way of returning to the draft are not considered returning players and must be returned to the open draft. Protected players must be named each year on the team's official roster. A protected player will lose their protected status when moving into a new age division.  
**Any deviations or special accommodations shall be submitted to the area TTA State Director for ruling prior to being initiated.**

#### **H. RETURNING ROSTERED PLAYERS**

Returning roster players are not considered protected players, returning roster players are players that were drafted their first year in an age division that are legally signed up and returning to their team roster the following year in the same age division. Returning roster players are also tied to the same team roster (not the coach) remaining in the same age division. Second year returning rostered players in the same age division may not be returned to the open draft. Players moving into a new age division must enter into the open draft and are not considered returning rostered players.

**Any deviations or special accommodations shall be submitted to the area TTA State Director for ruling prior to being initiated.**

#### **I. TEAM ROSTER**

In most circumstances, when a manager/head coach is assigned to a team roster, there will be returning players and/or protected players that are still a part of that team roster from the previous year.

Manager/head coach(s) assigned to a roster will inherit what players remain on the roster from the previous year, as is. Manager/head coach(s) will add protected players as needed or required by rule and add new players through the open draft to re-establish a complete team roster for the current season.

- If a returning team roster has only 3 players or less, that roster may be dissolved and players returned back to the open draft. It will be determined by the local board or the affiliate league board to adopt this into their local rules to dissolve a roster and place returning players back into the draft once the roster reaches 3 or less, prior to sign-ups beginning.

#### **J. OPEN DRAFT RULES**

1. A team drafting order must be an alternating pick format, drafting order will be determined by the local board.
2. Each team will have 1-3 protected players listed on their roster prior to the open draft beginning. Returning team rosters will also have returning players listed on their roster. The total number of protected, returning players and any automatic sibling rule players needs to be calculated and totaled for each team.

3. Teams with the lowest number of players will get to equal up on the number of players to the next closest team. Once two (2) or more teams are equal with the number of players, then alternating picks will start between the teams that are equal. This will continue until all teams are equal on the total number of players per team and then alternating picks until all players have been selected.
4. Parents requesting for their son(s) or daughter(s) to play or not play for a certain manager/coach or team **is not allowed**. Any player refusing to play for a team when chosen in the selection process is ineligible to play for any team.
5. It is the responsibility of each affiliate to govern their leagues to prevent the stacking of teams. Any and all teams that are determined to be an illegally drafted team by a TTA State Director(s) or the Affiliate Local Board will not be allowed to participate in tournament play.
6. Any manager/coach who violates the player selection system in any way, shall be suspended from participation in TTAB/TTAS for any period of time, not to exceed three (3) years. Likewise, the affiliates/league with whom the coach is associated with, shall be subject to the same penalty.

**Any deviation or special accommodations shall be submitted to the area TTA State Director for ruling prior to being initiated.**

#### **K. PLAYER AGREEMENTS**

1. All players and their parents (or guardians) shall be required to sign a player agreement prior to participating in any TTA activity, agreeing to abide by all TTA rules and regulations and, in addition, all local affiliate rules and regulations. The player agreement must include a statement releasing the local league affiliate and its officers, all sponsors, and the TTA State Organization from any and all liability associated with any injuries sustained as a result of any TTA activity.
2. Each player (parent or guardian) must provide the local affiliate town an official (copy thereof) birth certificate, passport or official military dependent I.D. as documented proof of the correct date of birth. State issued identification cards, foreign birth certificates and/or government resident alien documentation is acceptable so long as proof of the correct date of birth is validated on such documentation. It is encouraged that the parent or legal guardian provide this legal documentation at sign ups.

**\*\*Hospital record of birth certificate will not be accepted as legal documentation\*\***

3. Players drafted will be considered the property of the team who drafted them for the age eligible age division.
4. Players participating in TTA will be eligible to play on only one TTA team in one league in one season. This excludes players on High School Eligible Boys and Girls Teams.
5. A Player must participate/play in at least one half of the regular season games (unless for medical reasons), to be eligible for tournament play. A game not played due to forfeit is not considered participation.
6. Team rosters must be submitted to the TTA State database prior to the league's first scheduled game for that team. Failure to submit a team roster prior to the first scheduled game will result in forfeit of any game played prior to submission of the roster.
7. No additions to a team roster will be permitted after the first league game is played without State Director approval.
8. NO PLAYER TRADES WILL BE PERMITTED.

**L. ILLEGAL PLAYERS AND PENALTY**

1. The TTA Roster Audit Committee will perform random roster audits to ensure players remain with their assigned rosters through the current age division.
2. Players may be declared illegal for the following reasons:
  - (a) A player moved to another team without proper justification and/or local board and the State Director approval or traded.
  - (b) Misrepresentation of playing age.
  - (c) Participation on more than one TTAB/TTAS team during league play. (Exception: High School Boys and Girls Eligible Divisions, where approved).
  - (d) A maximum age player who is signed to a TTA team after eight other maximum age players are already signed.
  - (e) Not officially registered with a league to be a player.
  - (f) Players who reside or attend school in a defined affiliate boundary area and play outside that defined area when a TTA program is offered in his/her age division.

**PENALTY:** All games in which an illegal player participated will be forfeited.

3. It will be the responsibility of the Manager of each team to make sure that he/she does not draft or play an illegal player during the season or in tournament play. Penalty for this violation can be up to a two-year suspension of the Manager from participating in TTAB/TTAS activity.
4. In the event a Manager or Assistant Manager believes or knows of an opposing team playing an illegal player, he/she may make a protest. If the protest is allowed, the game will be declared forfeited to the offended team. Any game played in which both Managers have lodged an official protest, and both protests have been allowed, the game in question will be thrown out. The game will not be replayed, but will be recorded as a loss of one game for each of the teams in the final standings.
5. In the event local affiliate officials or State Directors discover an illegal player, manager, or team (according to TTAB/TTAS rules and regulations) all games in which player, manager or team participated, will be forfeited.
6. Any coach playing a player under an assumed name or with illegal documentation: player and coach will be removed from the game at the time the illegal player is identified.  
**PENALTY:** Player will be removed from play. Coach will receive a five (5) year suspension from TTA and player will be suspended for two (2) years. All games in which an illegal player participated will be forfeited.
7. **IT WILL BE THE RESPONSIBILITY OF THE MANAGER TO ENSURE THAT THE TEAM ROSTER IS SUBMITTED TO THE STATE OFFICE CORRECTLY AND PRIOR TO THE FIRST SCHEDULED TEAM GAME.** If a data entry mistake is discovered on a team roster (examples: omission of a player, spelling errors or typing entry mistakes) the player may be eligible to play with approval of the State Director. **PENALTY:** The manager may be suspended for the first two tournament games.

#### **M. PROTESTS AND DISPUTES – LEAGUE PLAY**

1. All protests and disputes arising during the regular season of league play shall be settled on a local level. The President of each affiliate shall name a Protest Committee for that purpose and the Committee's ruling shall be considered final.

2. A protest which may arise from interpretation of playing rules, will be made by notifying the Umpire-In-Chief and the manager of the opposing team, at the time of occurrence and before the next legal pitch, that the game is being played under protest; then submitting the protest in writing to the local affiliate President within twenty-four (24) hours after the game in question.
3. An Affiliate President who manages and/or coaches a team in TTAB/TTAS cannot serve or rule on a protest committee in his/her age division.

#### **N. UMPIRES FOR LEAGUE PLAY**

1. An official umpire is one that is approved and appointed by the Local Affiliate.
2. Local TTA organizations should select the most qualified umpires possible with at least one umpire for each league game and at least two for TTA tournament games. TTA encourages the use of Certified TTA Umpires for league play.
3. A State Director will not umpire or manage in any game.
4. Umpires will check all bats and required equipment prior to each game.

#### **O. SCOREKEEPERS/STATISTICIAN – LEAGUE PLAY**

Each team will furnish a competent scorekeeper/statistician for each game to record and keep an accurate record of: at bats, errors, extra base hits, strikeouts, walks, pitch count, bases on balls, and stolen bases. **The pitch count statistician is required to stop play immediately and notify the umpire when the Pitcher has reached his pitch count maximum. If not discovered and a violation occurs, the penalties will still be enforced (see applicable age division pitching rules for penalties)**

**The scorekeeper may notify of an improper batter only before the first pitch is thrown in the at bat. If not discovered before the first pitch is thrown, if discovered by the offensive or defensive coach before the batter becomes a runner, the proper batter may be inserted and will assume the count as it was for the improper batter, at this point it is correctable. Once the batter becomes a runner, a proper appeal may be made by the defensive coach before the next pitch, once confirmed that batting out of order has occurred, the player that was the improper batter will be called out, all base runners will return to their previously occupied bag. The next batter up will be the batter that follows the improper batter that was called out. If a batter was skipped due to batting out of order, that batter will lose that at bat.**

**P. SCORING RULES**

To achieve uniformity in keeping the records of league and championship games, the scorekeepers must conform to the Official Scoring Rules as listed in the NFHS Baseball rulebook and the USA Softball Official rulebook.

**Q. QUALIFYING LEAGUES FOR TOURNAMENT PLAY**

1. In order for a team to be eligible to participate in Texas Teen-Age Tournament play, it is mandatory that the following qualifying steps be taken:
  - (a) Register and become a member of the State Association.
  - (b) Make payment in full of the annual registration fees of thirty dollars (\$30) per team.
  - (c) Complete and submit Official Team Rosters to State Office prior to the first scheduled team game.
  - (d) Strictly abide by tournament rules as set forth in "Tournament Rules" section of this rulebook.
  - (e) Follow the general pattern of TTAB/TTAS and comply fully with the entire standard playing rules and regulations as established by TTAB/TTAS.
2. It will be the duty and responsibility of the State Association President to rule on the qualifications and eligibility of all active member leagues for tournament play. Any ruling or decision made by the State Association President will be considered final.

**R. MEDICAL INSURANCE**

It is the obligation of each affiliate participating in TTAB/TTAS to maintain medical insurance on its players prior to the affiliate's first league game. Coverage should extend through tournament play for those qualifying. TTAB/TTAS is not responsible for any damages resulting from an injury occurring when insurance coverage is not in effect. **PENALTY:** Forfeiture of every league or tournament game played without proper insurance coverage provided by the affiliate on the players.

**S. TTA COPYRIGHT AND TRADEMARKS**

All affiliates are required to obtain permission to use any TTA copyrighted trademarks: TTAB, TTAS, TTAB-TTAS, Texas Teen-Age Baseball, Texas Teen-Age Softball, Texas Teen-Age Baseball/Softball or either logo as shown below:



Permission is required for the use of these copyrighted trademarks for caps, visor, t-shirts, programs or any other materials.

## OFFICIAL RULES

LEAGUE PLAY IN ALL DIVISIONS SHALL BE COVERED BY NFHS (NATIONAL FEDERATION OF STATE HIGH SCHOOL) AND/OR USA SOFTBALL ASSOCIATION OFFICIAL RULES INCLUDING BATTING OUT OF ORDER, UNREPORTED SUBSTITUTIONS AND ILLEGAL SUBSTITUTIONS WITH THE FOLLOWING EXCEPTIONS

### **10. GENERAL RULES APPLICABLE TO ALL DIVISIONS**

#### **10-1. LOCAL AFFILIATE RULES**

- (a) Ground Rules shall be furnished to team managers and umpires. Ground rules shall apply to playing field conditions only.
- (b) Special Rules are applicable to local league play only.

#### **10-2. HIDDEN BALL TRICK**

The hidden ball trick will not be permitted in any division. No play shall be allowed or permitted resulting from a hidden ball trick.

#### **10-3. INTENTIONAL WALK**

An intentional walk may be issued by merely notifying the umpire of the intention. Intentional walks will not affect pitch count. Not applicable to Boys and Girls 6U T-Ball, Boys and Girls 8U Coach Pitch Divisions.

#### **10-4. ON DECK CIRCLE**

On-deck hitters will be allowed to utilize either on deck circle in all softball and baseball divisions. Exception: HSE Girls and Boys

#### **10-5. BENCH AND FIELD CONDUCT**

A coach, player, substitute, attendant, fan or other bench personnel shall not:

- (a) Deliberately throw a bat or helmet. Throwing of bat: to be considered throwing a bat it must be deliberate and leave the batter's hand. If a batter throws his bat, he is not out if a fair ball was hit, but he may be removed from the game. Hitting the catcher on a back swing is not considered throwing a bat.

- (b) By calling “time” or use any command or commit any act for the purpose of trying to cause the opposing pitcher to balk or illegal pitch.
- (c) Use word, act or noisemakers to incite, or try to incite spectators or players. Abusive or profane language is prohibited.
- (d) Use or appear to be under the influence of any intoxicants at a TTAB or TTAS sanctioned event.
- (e) Enter the area behind the catcher while the opposing pitcher and catcher are in their positions.
- (f) Fake a tag without the ball.
- (g) Maliciously run into a fielder with or without the ball. When a defensive player has the ball in his possession waiting to make a tag on a base runner, and runner deliberately runs into defensive player. EFFECT: Runner is out. Ball is dead. All other runners must return to base last touched at the time of the collision. If act is deemed flagrant by the umpire, the offender will also be ejected. **PENALTY:** In (a), (b), (c), (d), (e), (f), and (g), umpire shall banish the offender from the field. Failure to comply shall result in game being forfeited. However, in (e), if the offense is judged to be a minor nature, the umpire may warn the offender and then disqualify him if he repeats the offense.
- (h) Use noisemaker at any TTAB/TTAS game.
- (i) A one game suspension, for any player and or coach that is ejected from a game due to unsportsmanlike behavior, malicious contact and/or violation of the pitch count.

#### **10-6. CHARGED CONFERENCES**

- (a) A charged conference is defined as when a coach, player, or team representative calls timeout from the dugout and stops play to confer with one or more of the defensive players.
  - 1) If a coach walks across the diamond between innings and talks to a player as he returns to his dugout and does not delay the game in any manner, it is not a charged conference.
  - 2) Time granted for an obviously incapacitated player will not constitute a charged conference. Nor will a conference be charged whenever the pitcher is removed.

- 3) If a pitcher is removed by the coach, a charged conference will not be issued to the team.
- (b) Baseball – Three (3) charged conferences per game; only one (1) charged conference is allowed per inning without penalty.
- (c) Softball – Refer to USA Softball rules.
- (d) PENALTY: for (b) and (c), Removal of pitcher from the pitching position for the duration of the game.
- (e) In any extra inning game, each team will be permitted one charged conference each inning while on defense without penalty. The number of charged conferences permitted is not cumulative.
- (f) Each team, when on offense, may be granted not more than one charged conference per inning to permit the manager or any of that team's personnel to confer with base runners and/or the batter. The umpire shall deny any subsequent request for charged conferences. Violation will result in the manager being restricted to the dugout for the remainder of the game.
- (g) Each manager should be notified when he is charged with a charged conference.

#### **10-7. EQUIPMENT**

- (a) ANY person under the age of 18 years, warming up a pitcher in any position, whether sitting or standing, will wear a facemask. NO LEAGUE OR TOWN CAN WAIVE THIS RULE. First offense – removal of coach from the game, second offense – forfeit the game.
- (b) ALTERED OR ILLEGAL BATS: When a batter enters the batter's box with, or is discovered using an altered or illegal bat, the batter is declared out and the batter and manager are ejected from the game. The ball is dead and each runner must return to the last base touched at time of pitch.
- (c) Choke up spacers will not be allowed in any TTA game.
- (d) Umpires will check all bats and required equipment prior to each game in tournament.
- (e) Double sided first base will not be allowed in any boys age division. Ensure the proper field equipment is in place prior to the game starting.

**10-8. JEWELRY**

Exposed jewelry, which is judged by the umpire to be dangerous, must be removed and may not be worn during the game. Medical alert bracelets or necklaces are not considered jewelry. If worn, they must be taped to the body so the medical alert info remains visible.

**10-9. BLOOD RULE**

A player, coach, or umpire who is bleeding or who has blood on his uniform shall be prohibited from participating further in the game until appropriate treatment can be administered. If medical care or treatment is administered in a reasonable length of time, the individual will not have to leave the game. The length of time that is considered reasonable is left to the umpire's judgment. Uniform rule violations will not be enforced if a uniform change is required. The umpire shall:

- (a) Stop the game and allow treatment if the injured player would affect the continuation of the game.
- (b) Immediately call a coach, trainer or other authorized person to the injured player.
- (c) Apply the rules of the game regarding substitutions, short-handed player, and re-entry if necessary.

**10-10. INFIELD FLY RULE**

The Infield Fly Rule will apply to all TTA leagues except in boys and girls 6U and 8U leagues

**10-11. GAME TIME IS FORFEIT TIME**

**10-12. SLINGING THE BAT RULE APPLICABLE TO ALL AGE DIVISIONS, GIRLS AND BOYS**

If the batter slings the bat, anything other than malicious intent, a delayed dead ball will be indicated and the player will receive one warning. If the same batter has a second offense, the ball is dead and the batter is out. No runner may score or advance and must be returned to the base occupied at the time of the dead ball play/pitch.

**10-13. TIME LIMITS (League Play)**

**Local affiliates may establish time limits for its league play schedule. Recommended time limits are as listed below.**

- All girls division – 1 hr 30 min
- Boys 6U, 8U, 10U & 12U – 1 hr 30 min
- Boys 14U – 2 hr

**10-14. COURTESY RUNNER RULE**

A courtesy runner for the pitcher is allowed in all games (baseball and softball), except Boys and Girls 6U T-Ball, Boys and Girls 8U Coach Pitch. A courtesy runner for the catcher will be allowed in all games (baseball and softball) except Boys and Girls 6U T-Ball. A courtesy runner must be an eligible player who is not in the current batting lineup or currently entered in the game. The same runner may not be a courtesy runner more than once per inning, except in the case where the same person, for whom he ran for, returns to the plate more than once per inning. The player must be eligible to re-enter the game under the TTA substitution rules, Example: A player who has been substituted for and re-entered the game, then taken out of the lineup is not eligible to courtesy run or re-enter the game.

**PENALTY: Pitcher removed from game and restricted to the dugout for the remainder of the game.**

**10-15. SHORT HANDED RULE**

(a) If a team begins play with the required number of players, 9 or 10 They can continue with one or two less players. Whenever a player(s) leaves the game for any reason other than ejection. Under no circumstances will a team be permitted to bat less than eight.

**PENALTY:** The game is forfeited for any violation.

(b) When the player(s) who has left the game is scheduled to bat, an out will be declared for each turn at bat. The player who has left the game cannot return to the lineup. Exception: A player who has left the game under the blood rule, may return even after missing a turn at bat.

(c) If a player leaves the game as a runner, player will be declared out.

#### 10-16. RE-ENTRY RULES

- (a) Any player may be substituted for or replaced and re-entered once provided the players occupy their same batting positions in the batting order. The starting player and the substitute may not be in the line-up at the same time. **PENALTY:** Player and Manager restricted to the dugout for the remainder of the game.
- (b) Violation of re-entry rule is handled as a protest when brought to the attention of the umpire by the offended team and may be made at any time during the game. (The protest need not be made prior to the next pitch).
- (c) **FOR TTAB ONLY**, once a pitcher is removed from the mound or line-up during a game as a pitcher they cannot return to the mound as a pitcher during that game. Exception: T-Ball and Coach Pitch
- (d) **PENALTY:** If an illegal pitcher returns to the pitching position and has thrown one pitch, it is a forfeit. This is not considered a re-entry violation so the manager is not ejected.
- (e) Refer to NFHS rulebook for clarification on un-reported and illegal substitutions.

#### 10-17. TEAM ROSTER

An Official Team will consist of a minimum of nine (9) players. You must have nine players to start a game and nine players to finish a game. (Exception: The Short Handed Rule – 10-15) **PENALTY:** Forfeit of the game. Applicable to District and State Tournaments only.

- (a) **Teams will have no more than eight (8) players who are the maximum league age.**
- (b) All team rosters may have no more than fifteen (15) players and Official Rosters must be sent to the State Office prior to the first scheduled team game. Only those players listed on Official Team Rosters registered with the State Office will be eligible for league and tournament play. Any player's name left off or changes made to Team Rosters after the first league game may disqualify players and teams from league or tournament play.

- (c) The line-up shall contain the first and last name, defensive position and uniform number of all players. All available substitutes should be listed in the designated place by their first and last name and uniform number. Lineup cards are required to be presented to the official books and the plate umpire before the game begins.
- (d) If a legal rostered player is not present at the start of the game, thus not listed on the lineup card or the books, and shows up after the game has started, that player(s) may be added to the lineup without penalty. **During tournament play:** any player added to the lineup after the game starts will fall under the participation rule (200-5)

#### **10-18 TEAM MANAGEMENT**

- (a) Each team shall have a head coach, not more than two assistant coaches, and a bat girl or boy.
- (b) All coaches must be 18 years of age or older for tournament games.
- (c) Two Offensive base coaches must be stationed near first and third bases.
- (d) One person is the “Official Manager” and only this person may call time out, discuss umpire calls, and make changes in lineup.
- (e) Only 2 coaches will be allowed on the field while their team is on offense. The other coach must remain in the dugout. **(Excluding Coach Pitch Divisions)**
- (f) While on defense, all coaches must remain inside or beside the team dugout. This will be enforced based on umpire discretion.

#### **10-19. GUIDELINES FOR WEATHER – LEAGUE PLAY**

1. TTA recommends all Associations have a working lightning detector for league games.
2. When thunder is heard or lightning is seen, the leading edge of the thunderstorm is close enough to strike your location with lightning. Suspend play for at least 30 minutes and vacate the outdoor activity to the previously designated safer location immediately.
3. 30 minute rule. Once play has been suspended, wait at least 30 minutes after the last thunder is heard or lightning is witnessed prior to resuming play.

4. Any subsequent thunder or lightning after the beginning of the 30-minute count will reset the clock and another 30-minute count should begin.
5. When lightning-detection devices or mobile phone apps are available, this technology could be used to assist in making a decision to suspend play if a lightning strike is noted to be within 10 miles of the event location. However, you should never depend on the reliability of these devices and, thus, hearing thunder or seeing lightning should always take precedence over information from a mobile app or lightning-detection device.

**10B. GENERAL RULES APPLICABLE TO TTAB  
(BOYS BASEBALL ONLY)**

LEAGUE PLAY IN BOYS BASEBALL DIVISIONS SHALL BE GOVERNED BY THE NFHS (NATIONAL FEDERATION OF STATE HIGH SCHOOL) RULES WITH THE EXCEPTIONS THROUGHOUT THE TTAB SECTIONS.

**10B-1. TTAB PLAYING AGE DATE:**

All Boys Divisions will play under the age as of August 31<sup>st</sup> of the current year.

**10B-2. TTAB LEAGUE SCHEDULE:**

The schedule shall be arranged so that no team will be required to play more than two (2) games per calendar week, except for playing of one (1) postponed, makeup, or suspended game.

**10B-3. PITCHING RULES:**

- (a) All TTA rules shall apply relating to pitching rules and no pitcher will exceed the total number of pitches allowed for their age division. See appropriate age division.
- (b) Pitcher is not considered a pitcher until the umpire has put the ball in play and the pitcher has thrown an official first pitch/or commits to a pitching action, example, pick-off attempt.
- (c) PITCH COUNT PENALTIES, violation of any of these pitching rules will result in:
  - Removal of the player from the mound and ejection of the Head Coach for the remainder of that game plus Head Coach from the next scheduled game.
  - Repeated violations, the local board has the authority to remove the coach for multiple games or suspension for the season
  - If a pitcher pitches during their required days of rest, that game will be a forfeit. All pitches thrown in the game will still be counted towards the official pitch count for all players.

**10B-4. EH (Extra Hitter), DH (Designated Hitter) IN TTAB**

**(Exception:** HSE Boys may only use DH)

- Designated Hitter may only be used in Boys 10U, 12U, 14U and HSE divisions.
- Extra Hitter (EH) may be used in any boys division except in the HSE division.
- Where applicable, the EH (Extra Hitter) and (NFHS) Designated Hitter or DH player is optional for any game. Both the EH and DH can be used together in any game, or the Manager may choose to just use one or neither option. If used in any combination, it must be made known prior to the start of the game and be listed on the lineup card and in the official game batting order.
- The EH may enter the game on defense at any time, but the batting order must remain the same, only the EH tag will move to another player when this happens. The EH position can be substituted for and re-entered like any other position.
- For clarification on the NFHS Designated Hitter rule, see the current NFHS rulebook,

**10B-5. EQUIPMENT RULES IN TTAB:**

- (a) **METAL SPIKES OR METAL CLEATS ARE NOT ALLOWED IN ANY BOYS DIVISION EXCEPT FOR BOYS 14U AND HIGH SCHOOL ELIGIBLE DIVISION ONLY. NO METAL CLEATS OR SPIKES ARE ALLOWED ON TURF FIELDS IN ANY AGE DIVISION. The penalty will be ejection from the game.**
- (b) All male catchers are required to wear protective cups (Except Boys 6U T-Ball). All catchers must wear helmets with protective ear flaps and throat guards (Except Boys 6U T-Ball). **Penalty is removal from the game until violation is corrected, if not corrected, the game will result in a forfeit.**
- (c) Approved standard baseball equipment, including bats, baseballs, uniforms, gloves, bases, pitcher and home plates will be used. Any equipment used contrary to the equipment approved in NFHS Baseball, USA Baseball or USSSA will be removed from the game by the umpire.

- (d) All non-wood bats must be stamped with either USA Baseball, BPF 1.15 or less or BB-COR. BB-COR or wood bats are required in Boys HSE Division. Any bat being used contrary to the requirements will be subjected to enforcement of rule 10-7 EQUIPMENT.
- (e) T-shirts and shorts or jeans may be worn in lieu of uniforms. T-shirts or jersey must be similar in color.
- (f) Numbers on uniforms will be optional in league play but will be required in all TTA Tournament play.
- (g) Offensive players (including the on deck batter) must wear batting helmets with double ear flaps.



**10B-7. PLAYING FIELD – TTAB TIGHT BASE DIVISIONS**

- (a) The infield will be a sixty (60) feet square.
- (b) The distance between all bases shall be sixty (60) feet.
- (c) In Boys 6U T-Ball, 8U Coach Pitch and Boys 10U Divisions. The distance between the point of home plate and the front side of the pitcher’s rubber will be forty-two feet (42’)
- (d) The distance from home plate to second base and from first base to third base will be eighty-four feet and 10 inches (84’ 10”).
- (e) The distance from home plate to the nearest fence or other obstruction on fair ground shall be one hundred eighty (180) feet or more.
- (f) The pitcher’s mound shall be raised by a gradual slope to a height of six (6) inches to ten (10) inches above the home plate and base line level.

Exception: Boys 6U T-Ball & 8U Coach Pitch

- (g) The pitcher’s rubber, home plate, and bases shall be of standard dimensions in accordance with NFHS rules.

**10B-8. PLAYING FIELD – BOYS 10U (OPEN BASE) DIVISION**

- (a) The infield will be a sixty five (65) feet square.
- (b) The distance between all bases will be sixty five (65) feet.
- (c) The distance between the point of home plate and the front side of the pitcher’s rubber will be forty-six feet (46).
- (d) The distance from home plate to second base and from first base to third base will be ninety-one feet and 11 inches (91’ 11”).
- (e) This distance from home plate to the nearest fence or other obstruction in fair ground shall be 180 feet or more.
- (f) The pitcher’s mound shall be raised by a gradual slope to a height of six (6) inches to ten (10) inches above the home plate and base line level.
- (g) The pitcher’s rubber, home plate, and bases shall be of standard dimensions in accordance with NFHS

**10B-9. PLAYING FIELD – BOYS 12U (OPEN BASE) DIVISION**

- (a) The infield will be a seventy (70) feet square.
- (b) The distance between all bases will be seventy (70) feet.

- (c) The distance between the point of home plate and the front side of the pitcher's rubber will be forty-seven feet, six inches (47' 6").
- (d) The distance from home plate to second base and from first base to third base will be ninety-nine (99) feet.
- (e) This distance from home plate to the nearest fence or other obstruction on fair ground shall be 180 feet or more.
- (f) The pitcher's mound shall be raised by a gradual slope to a height of six (6) inches to ten (10) inches above the home plate and base line level.
- (g) The pitcher's rubber, home plate, and bases shall be of standard dimensions in accordance with NFHS rules.

**10B-10. PLAYING FIELD – BOYS 14U DIVISION**

- (a) The playing field shall be eight-ninths (8/9) the size of a regulation playing field.
- (b) The distance between all bases will be eighty (80) feet.
- (c) The distance between the point of home plate and the front side of the pitcher's rubber will be fifty-three feet, nine and one-third inches (53' 9-1/3").
- (d) The distance from home plate to second base and from first to third base will be one hundred thirteen feet, one and one-half inches (113' 1-1/2").
- (e) The distance from home plate to the nearest fence or other obstruction of fair ground shall be two hundred twenty-five feet (225') or more.
- (f) The pitcher's mound shall be raised by a gradual slope to a height of six (6) inches to ten (10) inches above the home plate and base line level.
- (g) The pitcher's rubber, home plate, and bases shall be of standard dimensions in accordance with NFHS rules.

## OFFICIAL RULES FOR TTAB DIVISIONS

### 20. BOYS 6U T-BALL BASEBALL DIVISION

#### 20-1. PLAYING FIELD

- (a) An arc measuring ten (10) feet from the point at the back of home plate, from base line to base line, in front of the plate will be marked. This arc will be used to determine a legal fair ball when hit from the batting tee.
- (b) A pitcher's rubber will be placed at 42' from the point at the back of home plate to the front edge of the pitching rubber.
- (c) The batting tee will be positioned by the umpire near center point of home plate.
- (d) Base lines shall have marks at halfway points between home and first (for fielder position reference), first and second bases, between second and third bases, and between third and home plate.

#### 20-2. AGE ELIGIBILITY RULES

- (a) Boys 6U T-Ball will be age six (6) years and under.
- (b) Players whose age is seven (7) on September 1st of the current year will not be permitted to participate in the Boys 6U Division.

#### 20-3. TEAM EQUIPMENT

- (a) The batting tee will be of the adjustable type for normal strike zone.
- (b) Umpire's decision will be final in determining proper adjustment within the strike zone.
- (c) Catchers must wear a protective helmet with a protective mask. Chest protectors and shin guards are optional.
- (d) TTA approved baseball bats, or any T-Ball bats may be used.

#### 20-4. LENGTH OF GAME

- (a) The length of the game will be five innings or the required time limit.
- (b) When a team scores a maximum of seven runs or makes three outs in one inning, the team then shall go on defense.

- (c) Two and one half (2 ½) or Three (3) innings shall be considered a complete game if play is discontinued because of rain, darkness, or other causes, which make further play impossible. **League Play Only.**
- (d) A 15-run lead shall be considered a complete game, after three complete innings of play or an 8-run lead after four complete innings of play.
- (e) In case of a “runaway” ball game before the three innings are completed, the manager of the team that is being subjected to the loss may choose to call the game by advising the chief umpire. Once the game is terminated, the decision cannot be revoked; the final score will be the score when the game was terminated.

**20-5. BATTER STRIKE - BATTER STRIKE-OUTS**

- (a) Batter is out when he has three strikes. The ball is dead and base runners may not advance.
- (b) If the batter swings the bat past the hitting tee, it will be considered a strike.
- (c) If batter strikes the tee only, it will be considered a strike.
- (d) It will be called a strike if the ball is hit but does not go out of the ten foot arc. If the ball is fouled out of the ten-foot arc, it is a foul ball and not an out.
- (e) Number of practice swings allowable for each batter shall not exceed three. The fourth practice swing shall be called a strike. If the bat touches the ball on a practice swing and if the ball does not fall from the tee, it shall not be called a strike, unless it is the 4th practice swing.
- (f) If the ball stops inside the ten foot arc and is not moving, any defensive player or batter may pick up the ball and hand it to the umpire without the batter being awarded first base or being called out. If the batter interferes with the ball while the ball is in motion inside the ten foot arc, the batter will be called out for interference.

#### **20-6. BASE RUNNERS**

- (a) When the umpire has the ball on the tee and the catcher is in position, base runners shall not leave their bases until the ball has been hit. If a base runner leaves base before the batter hits the ball foul, the base runner must be returned to the base occupied. The ball is dead and no runner may score, nor runners advance. If the batter hits the ball fairly, the base runner leaving base before the batter hits the ball will be declared out. The ball is live and in play, unless with 2 outs, inning will be complete and no runners may score.
- (b) Runners may not advance if the ball is not hit outside of the ten foot arc. (Exception: Runners may advance when forced to advance because of batter being awarded first base due to ball being fielded inside the 10 foot arc by opposing player while the ball is in motion.

#### **20-7. CONTROL OF PLAYING ACTION**

- (a) To start play the umpire will place the ball on hitting tee and call "Batter Up".
- (b) Umpires will call "time" after every play and declare a ball dead. Time shall be called as soon as the lead runner is stopped from advancing by a defensive player. In TTA tournament play, "half-way" marks will be used. If trail runner/s have advanced past the halfway mark in the base line, they may continue to the next base; otherwise, runner must return to the previous base.
- (c) There is no intentional walk.

#### **20-8. OFFICIAL TEAM LINEUP**

T-Ball divisions may (optional) play with 10 in the batting lineup with the 10<sup>th</sup> player being either a 4<sup>th</sup> outfielder or play with 9 in the field with an EH (extra hitter)

#### **20-9 GENERAL RULES APPLICABLE TO BOYS 6U**

##### **T-BALL BASEBALL**

- (a) The ball must be hit from the batting tee by the batter to be a fair ball.
- (b) Pitcher and catcher must be in their proper position at the time the ball is hit.

- (c) All defensive infield players must remain behind the thirty (30) foot halfway line until the ball is hit.
- (d) All outfield player positions must be behind the base line until the ball is hit.
- (e) The pitcher must remain in contact with the pitching rubber until the ball is hit. Continued violation shall be removal of the pitcher from the pitching position.

**Penalty for (c), (d) & (e)**

- If the ball is not hit fair or in play, move the defensive player(s) back to their correct position and tell them not to move forward before the ball is hit.
  - If the ball is hit fair and in play, and the player in violation makes the initial play on the ball, let the play continue and once the play has stopped, the umpire will put runner(s) in the position, in his opinion, the runner(s) would have reached if the violation would not have occurred.
  - If the ball is hit fair and in play, and the player in violation does not make the initial play on the ball, the play is live, and no penalty will be enforced.
  - In addition to the above penalties, give the Head coach a warning. If the violation continues after warning the coach, the coach may be ejected.
- (f) For the ball to be live, the ball must be touching the chalk of the ten-foot arc or hit outside of the ten-foot arc to be fielded and for runners to advance.
  - (g) If an opposing player fields a ball that is rolling from within the ten-foot arc, the batter will be awarded first base.
  - (h) As long as the ball remains inside the playing field, the base runner may continue to run until the lead runner is stopped.
  - (i) Bunting is not permitted. Full swing must be taken, or shall be called out and ball is dead.
  - (j) Infield fly rule is not in effect in Boys T-Ball.
  - (k) Pitcher may return to the pitching position unless removed for excessive conferences or failure to stay in contact with the pitching rubber until ball is hit.
  - (l) If a fly ball is caught by any fielder, all runners must tag up. Any runner that did not tag up must return to the base. If runners have tagged up properly, they may advance. If the lead runner did not tag up, and trailing runners did tag up, the lead runner determines if runners return to their bases.
  - (m) Refer to Section 10 for additional applicable General rules.

## OFFICIAL RULES

### 30. BOYS 8U COACH PITCH DIVISION

#### 30-1. AGE ELIGIBILITY RULES

- (a) Boys 8U Coach Pitch Division ages will be eight (8) years of age and under.
- (b) Players whose age is nine (9) on September 1st of the current year will not be permitted to participate in the Boys 8U Division.

#### 30-2. LENGTH OF GAME

- (a) The length of the game will be six (6) innings or the required time limit.
- (b) Three and one-half (3½) or four (4) innings shall be considered a complete game if play is discontinued because of rain, darkness, or other cause.
- (c) A game is a complete game after three and one-half (3½) or four (4) innings with a 15 run lead or after 5 innings with an 8 run lead.

#### 30-3. BASE RUNNERS

- (a) If a base runner leaves base before the pitched ball reaches the batter and the batter does not hit the ball, the base runner must be returned to the base occupied before the pitch was made, the ball is dead and no runner may score nor runners advance. All pitches will be counted as either a ball or strike, even though ball is called dead.
- (b) If the baserunner leaves the base before the pitched ball reaches the batter and the ball is hit fairly, the base runner leaving base before the pitched ball reaches the batter, shall be declared out, the ball is live and in play, unless with 2 outs, where the baserunner leaving early becomes the 3rd out, the inning will be complete and no runners may score.

#### 30-4. GENERAL RULES APPLICABLE TO BOYS 8U COACH PITCH

- (a) A maximum of 7 runs per inning or 3 outs in all innings.

- (b) Umpires will call “time” after every play and declare a ball dead. Time shall be called as soon as the lead runner is stopped from advancing by a defensive player. In TTA tournament play, “half-way” marks will be used. If trail runner/s have advanced past the halfway mark in the base line, they may continue to the next base; otherwise, runner must return to the previous base.
- (c) There are no walks or “base on balls”, intentional or otherwise.
- (d) No bunting is allowed. Full swing must be taken. **PENALTY:** Batter attempting to bunt, ball is dead, batter is out, no runner/s may advance.
- (e) The Infield Fly Rule does not apply in Boys 8U Coach Pitch.
- (f) A batter will receive a maximum of five pitches or three swinging strikes, whichever occurs first. If the fifth pitch or subsequent pitch is hit foul, the batter will remain at bat as long as they continue to foul the pitch.
- (g) No drop third strike rule.
- (h) No stealing.
- (i) The distance of the pitching rubber is 42’ from the point of home plate to the front edge of the pitcher’s rubber.
- (j) Pitching must be an overhand motion.
- (k) The Pitching Coach must keep one foot on or straddle the pitching rubber until the pitch released. The pitching coach must be in a standing position.
- (l) The Pitching Coach is allowed to verbally position the batter. The Pitching Coach will not be allowed to communicate with any other player, Coach, or umpire while in the Pitching position while on offense either verbally or physically.
  - **(PENALTY: Removal of the Pitching Coach)**
  - **If the pitching coach is the head coach, the head coach will be allowed to use their one offensive conference while in the pitching position, per half inning.**

- Once the ball has been hit, the Pitching Coach must position himself/herself as not to interfere with the defensive team or player on any play at all.
  - **(PENALTY: The ball will be dead and batter will be called out and no other runners will advance or score, unless with 2 outs, inning will be complete and no runners may score)**
- (m) If the batted ball hits the Pitching Coach, the umpire will judge if the Pitching Coach made a legitimate attempt to get out of the way, the ball becomes dead. All runners advance one base. Batter is awarded first base. If the umpire rules the Pitching Coach did not make the attempt to get out of the way, then the batter is declared out. No runner shall advance.
- (n) The defensive player listed as pitcher must be no further than four (4) feet behind or beside the pitching rubber until the ball has been hit.
- Penalty:**
- If the ball is not hit fair or in play, move the defensive player(s) back to their correct position and tell them not to move forward before the ball is hit.
  - If the ball is hit fair and in play, and the player in violation make the initial play on the ball, let the play continue and once the play has stopped, the umpire will put runner(s) in the position, in his opinion, the runner(s) would have reached if the violation would not have occurred.
  - If the ball is hit fair and in play, and the player in violation does not make the initial play on the ball, the play is live, and no penalty will be enforced.
  - In addition to the above penalties, give the Head Coach a warning. If the violation continues after warning the coach, the coach may be ejected.
- (o) Pitcher may return to the pitching position unless removed for penalty
- (p) The catcher must be in the squat position in the catcher box and ready to receive the pitch.

## OFFICIAL RULES

### 40. BOYS 10U DIVISIONS

#### 40-1. AGE ELIGIBILITY RULES (BOYS 10U)

- (a) Boys 10U Division ages will be ten (10) and under.
- (b) Players whose age is eleven (11) on September 1st of the current year will not be permitted to participate in the Boys 10U Division.

#### 40-2. LENGTH OF GAME

- (a) The length of the game will be six (6) innings or the required time limit.
- (b) Three and one-half or four innings will be considered a complete game if play is discontinued because of rain, darkness or other causes which make further play impossible.
- (c) A ten run lead shall be considered a complete game after three and one half (3 ½) or four (4) innings of play, or 15 runs after two and one half (2 ½) or three (3) innings of play.

#### 40-3. PITCHING RULES

- (a) At league Age 10 and Under pitcher shall not throw more than 75 pitches in the same game or on the same calendar day. Exception: If the pitcher reaches the maximum pitch count limit while facing a batter, he may continue to pitch until the batter reaches base safely or is put out.
  - 1) If a pitcher throws 1 – 35 pitches he is not required any rest.
  - 2) If a pitcher throws 36 – 50 pitches he is required one day of rest
  - 3) If a pitcher throws 51 – 65 pitches he is required two days of rest
  - 4) If a pitcher throws 66+ pitches he is required three days of rest
- (b) A pitcher shall be allowed to pitch in two or more games on the same day provided he does not throw more than 75 pitches total in that calendar day.

- (c) Violation of any of these pitching rules will result in the removal of the player from the mound and ejection of the head coach for the remainder of that game plus suspension of head coach from the next scheduled game. Repeated violations, the local board has the authority to remove the coach for multiple games or suspension for the season
- (d) If a pitcher pitches during their required days of rest, that game will be a forfeit. All pitches thrown in the game will still be counted towards the official pitch count for all players.
- (e) The pitch count will be kept by each team. The coach will get the pitch count from the statistician at the end of each half inning. Statistician will not be bothered during the inning.
- (f) If a game is suspended by darkness, weather or other causes and resumed the following calendar day, the pitcher of record at the time the game was halted may continue to the extent of his eligibility, provided he has thrown 35 pitches or less. **(See: Pitch Counts in a Suspended Game page 7)**
- (g) Days of rest shall be calendar days.
- (h) If the pitcher is removed from the mound, or lineup, during a game, he may not return to the mound as a pitcher during that game.
- (i) TTAB pitching rules will not be superseded nor altered in any manner by local affiliate rules.
- (j) There will be no balks called in the Tight Base divisions. Balks will be called in Open Base games. A balk will not count towards pitch count totals.  
(Tournament play will also be governed by this rule.)

#### **40-4. BATTER STRIKE-OUTS**

- (a) In Tight Base Divisions, a batter is out when he has three strikes, either called or swinging. The batter is out, but the ball is in play and base runners may advance at their own risk.
- (b) For Boys 10U Open Base, a batter may advance to first if a third strike is not caught by the catcher, providing first base is unoccupied or first base is occupied with two outs.

**40-5. BASE RUNNERS (Tight Base Only)**

All base runners must remain in contact with the base, while the pitcher is in contact with the pitching rubber and the catcher is in the catcher's box ready to receive delivery of the pitch, until the ball reaches the batter.

- 1) If runner/s leave the base before the ball reaches the batter and ball is not hit fair, the runner/s will be returned to the base occupied before the pitch was made, unless the runner is put out by the defensive team. The ball becomes dead. No runners may score nor runners advance.
- 2) If the baserunner leaves the base before the pitched ball reaches the batter and the ball is hit fairly, the base runner leaving the base before the pitched ball reaches the batter, shall be declared out, the ball is live and in play, unless with 2 outs, where the base runner leaving early becomes the 3rd out, the inning will be complete and no runners may score.

**40-6. BASE RUNNERS (OPEN BASE ONLY)**

Base runners may leave a base prior to a pitch subject to the Rules under NFHS.

## OFFICIAL RULES

### 50. BOYS 12U DIVISION OPEN BASE

#### 50-1. AGE ELIGIBILITY RULES

- (a) Boys 12U Division ages will be age twelve (12) and under.
- (b) Players whose age is thirteen (13) on September 1st of the current year will not be permitted to participate in the Boys 12U Division.

#### 50-2. LENGTH OF GAME

- (a) The length of game will be six (6) innings or the required time limit.
- (b) Three and one half or four innings will be considered a complete game if play is discontinued because of rain, darkness or other causes which make further play impossible.
- (c) A ten run lead shall be considered a complete game after three and one half or four innings, or 15 runs after two and one half (2 ½) or three (3) innings.

#### 50-3. PITCHING RULES

- (a) At League Age 12 and Under pitcher shall not throw more than 85 pitches in the same game or on the same calendar day.  
Exception: If the pitcher reaches the maximum pitch count limit while facing a batter, he may continue to pitch until the batter reaches base safely or is put out.
  - 1) If a pitcher throws 1 – 35 pitches he is not required any rest.
  - 2) If a pitcher throws 36 – 50 pitches he is required one day of rest
  - 3) If a pitcher throws 51 – 65 pitches he is required two days of rest
  - 4) If a pitcher throws 66+ pitches he is required three days of rest.
- (b) A pitcher shall be allowed to pitch in two or more games on the same calendar day provided he does not throw more than 85 pitches total.
- (c) Violation of any of these pitching rules will result in the removal of the player from the mound and ejection of the head coach for the remainder of that game plus suspension of head coach from the next scheduled game. Repeated violations, the local board has the authority to remove the coach for multiple games or suspension for the season.

- (d) If a pitcher pitches during their required days of rest, that game will be a forfeit. All pitches thrown in the game will still be counted towards the official pitch count for all players.
- (e) The pitch count will be kept by each team. The coach will get the pitch count from the statistician at the end of each half inning. Statistician will not be bothered during the inning.
- (f) If a game is suspended by darkness, weather or other causes and resumed the following calendar day, the pitcher of record at the time the game was halted may continue to the extent of his eligibility, provided he has thrown 35 pitches or less. **(See: Pitch Counts in a Suspended Game page 7)**
- (g) Days of rest shall be calendar days.
- (h) If the pitcher is removed from the mound, or lineup, during a game, he may not return to the mound as a pitcher during that game.
- (i) TTAB pitching rules will not be superseded nor altered in any manner by local affiliate rules.
- (j) There will be balks called in all games. A balk will not count towards the pitch count totals (Tournament play will also be governed by this rule.)

**50-4. BATTER STRIKE OUTS**

For Boys 12U Open Base, a batter may advance to first if a third strike is not caught by the catcher, providing first base is unoccupied or first base is occupied with two outs.

**50-5. BASE RUNNERS**

Base runners may leave a base prior to a pitch subject to the Rules under NFHS.

## OFFICIAL RULES

### 60. BOYS 14U DIVISION

ALL LEAGUE PLAY IN BOYS 14U SHALL BE GOVERNED BY THE NFHS (NATIONAL FEDERATION OF STATE HIGH SCHOOL) RULES WITH THE FOLLOWING EXCEPTIONS:

#### 60-1. AGE ELIGIBILITY RULES

- (a) Boys 14U Division age will be fourteen (14) and under.
- (b) Players whose age is fifteen (15) on September 1st of the current year will not be permitted to participate in the Boys 14U Division.

#### 60-2. LENGTH OF GAME

- (a) The length of the game will be seven (7) innings or the required time limit.
- (b) A ten run lead shall be considered a complete game after four and one-half or five innings of play. Or 15 runs after three and one half (3½) or four (4) innings.
- (c) Four and one-half (4 ½) or five (5) innings of play will be considered a complete game if play is discontinued because of rain, darkness, or other causes, which make further play impossible.

#### 60-3. PITCHING RULES

- (a) At League Age 14 and Under pitcher shall not throw more than 95 pitches in the same game or on the same calendar day. Exception: If the pitcher reaches the maximum pitch count limit while facing a batter, he may continue to pitch until the batter reaches base safely or is put out.
  - 1) If a pitcher throws 1 – 35 pitches he is not required any rest.
  - 2) If a pitcher throws 36 –50 pitches he is required one day of rest.
  - 3) If a pitcher throws 51 – 65 pitches he is required two days of rest
  - 4) If a pitcher throws 66+ he is required three days of rest.
- (b) A pitcher shall be allowed to pitch in two or more games on the same calendar day, provided he does not throw more than 95 pitches total.

- (c) Violation of any of these pitching rules will result in the removal of the player from the mound and ejection of the head coach for the remainder of that game plus suspension of head coach from the next scheduled game. Repeated violations, the local board has the authority to remove the coach for multiple games or suspension for the season
- (d) If a pitcher pitches during their required days of rest, that game will be a forfeit. All pitches thrown in the game will still be counted towards the official pitch count for all players.
- (e) The pitch count will be kept by each team. The coach will get the pitch count from the statistician at the end of each half inning. Statistician will not be bothered during the inning.
- (f) If a game is suspended by darkness, weather or other causes and resumed the following calendar day, the pitcher of record at the time the game was halted may continue to the extent of his eligibility, provided he has thrown 35 pitches or less. **(See: Pitch Counts in a Suspended Game page 7)**
- (g) Days of rest shall be calendar days.
- (h) If the pitcher is removed from the mound, or lineup, during a game, he may not return to the mound as a pitcher during that game.
- (i) TTAB pitching rules will not be superseded nor altered in any manner by local affiliate rules.
- (j) There will be balks called in all games. A balk will not count towards the pitch count totals (Tournament play will also be governed by this rule.)

**60-4. ELIGIBILITY TO PLAY IN OTHER TTA LEAGUES**

Players who are registered in the Boys 14U Division are not prohibited from playing in the TTA High School Eligible Division if eligible to play the following year in High School. (Refer to High School Eligible Rules.)

**60-5. TEAM EQUIPMENT**

**METAL SPIKES OR METAL CLEATS ARE NOT ALLOWED IN ANY BOYS DIVISION EXCEPT FOR BOYS 14U AND HIGH SCHOOL ELIGIBLE DIVISION ONLY. NO METAL CLEATS OR SPIKES ARE ALLOWED ON TURF FIELDS IN ANY AGE DIVISION. The penalty will be ejection from the game.**

## OFFICIAL RULES

### 70. HIGH SCHOOL ELIGIBLE BOYS

ALL LEAGUE PLAY IN HIGH SCHOOL ELIGIBLE DIVISION SHALL BE GOVERNED BY THE NFHS (NATIONAL FEDERATION OF STATE HIGH SCHOOL) RULES WITH THE FOLLOWING EXCEPTIONS:

#### 70-1. PLAYING FIELD

- (a) The playing field will be of standard dimensions in accordance with NFHS Baseball Rules.
- (b) The distance between all bases will be ninety (90) feet.
- (c) The distance from the point of home plate to the front side of the pitcher's rubber will be sixty feet, six inches (60' 6").

#### 70-2. AGE ELIGIBILITY RULES

To participate in TTA High School Eligible leagues, players must be eligible to play in the following year on a high school team.

#### 70-3. TEAM EQUIPMENT

- (a) NFHS approved baseball equipment including baseballs, bats, uniforms, gloves, bases, and pitcher and home plates will be used.
- (b) Bats may be of wood, approved BBCOR aluminum, or BBCOR graphite.
- (c) **METAL SPIKES OR METAL CLEATS ARE NOT ALLOWED IN ANY BOYS DIVISION EXCEPT FOR BOYS 14U AND HIGH SCHOOL ELIGIBLE DIVISION ONLY. NO METAL CLEATS OR SPIKES ARE ALLOWED ON TURF FIELDS IN ANY AGE DIVISION. The penalty will be ejection from the game**

#### 70-4. LENGTH OF GAME

- (a) The length of the game will be seven (7) innings.
- (b) A ten run lead shall be considered a complete game after four and one-half or five innings of play. Or 15 runs after three and one half (3½) or four (4) innings.
- (c) Four and one-half (4 ½) or five (5) innings of play will be considered a complete game if play is discontinued because of rain, darkness, or other causes, which make further play impossible.

**70-5. PITCHING RULES**

- (a) HSE State Tournament Pitching Rules: All pitchers will be limited to 110 total pitches in the tournament. The pitcher may finish the batter.
- (b) ANY person under the age of 18 years, warming up a pitcher in any position, whether sitting or standing, will wear a facemask. NO LEAGUE OR TOWN CAN WAIVE THIS RULE. First offense – removal of coach from the game; Second offense – forfeit the game.

**70-6. ELIGIBILITY IN OTHER TTA LEAGUES**

Players who are registered on a High School Eligible Team are allowed to play on a Boys 14U Division team.

**10S. GENERAL RULES APPLICABLE TO TTAS  
(GIRLS SOFTBALL ONLY)**

ALL LEAGUE PLAY IN GIRLS SOFTBALL DIVISIONS SHALL BE GOVERNED BY THE OFFICIAL FAST PITCH (JUNIOR OLYMPICS) SOFTBALL RULES OF THE USA SOFTBALL ASSOCIATION WITH THE FOLLOWING EXCEPTIONS: (Exception is High School Eligible Girls playing NFHS (National Federation of State High School rules)

**10S-1 TTAS PLAYING AGE DATE**

TTAS (Softball) playing age will be the age of the player as required by USA Softball currently August 31<sup>st</sup> of the previous year

**10S-2. TTAS LEAGUE SCHEDULE**

The schedule shall be arranged so that no team will be required to play more than three (3) games per calendar week, except for playing of one (1) postponed, makeup, or suspended game.

**10S-3. TEAM EQUIPMENT**

- (a) Approved standard softball equipment, including bats, softballs, uniforms, gloves, bases, pitcher and home plates will be used. Any equipment used contrary to the equipment approved in USA Softball or USSSA will be removed from the game by the umpire.
  - All bats used in TTAS must be no larger than 2 1/4" diameter and have the appropriate stamp for USA Softball or USSSA BPF 1.20.
- (b) The 11-inch size ball will be used for Girls 6U T-Ball, Girls 8U Coach Pitch and Girls 10U Divisions and 12-inch size ball for Girls 12U, Girls 15U and High School Eligible Divisions.
- (c) Catchers must wear a mask with throat protector, approved helmet with double ear flaps, shin guards that offer protection to the knee caps, and chest protector. An extended wire protector may be worn in lieu of a throat protector attached to the mask.
- (d) TTAS divisions will require the NOCSAE approved face mask/guard as required equipment for batting helmets.

- (e) **METAL SPIKES OR METAL CLEATS ARE NOT ALLOWED IN ANY GIRLS DIVISION EXCEPT FOR GIRLS 15U AND HIGH SCHOOL ELIGIBLE GIRLS DIVISION ONLY. NO METAL CLEATS OR SPIKES ARE ALLOWED ON TURF FIELDS IN ANY AGE DIVISION. The penalty will be ejection from the game.**
- (f) T-shirts and shorts or jeans may be worn in lieu of uniforms. T-shirts or jersey must be similar in color.
- (g) Numbers on uniforms will be optional in league play but will be required in all TTA Tournament play.
- (h) Offensive players (including the on deck batter) must wear batting helmets with double ear flaps.

**10S-4. INFIELD FLY RULE**

The infield fly rule is applicable to all leagues except Girls 6U T-Ball and Girls 8U Coach Pitch.

**10S-5. CHARGED CONFERENCE**

Charged conferences in TTAS will be played by USA Softball rules.

**10S-6. EH (Extra Hitter) IN TTAS:**

- The EH player is optional in all girls age divisions (except HSE Girls) but if used it must be made known, prior to the start of the game and be listed anywhere on the line-up card in the regular batting order. The EH may enter the game on defense at any time, but the batting order must remain the same throughout the game. The EH position can be substituted for and re-entered like any other position.
- Tball divisions may (optional) play with 10 in the batting lineup with the 10<sup>th</sup> player being either a 4<sup>th</sup> outfielder or play with 9 in the field with an EH (extra hitter)

**10S-7. DP/Flex Player**

The DP/Flex player position is allowed in Girls 10U, Girls 12U, Girls 15U and HSE girls divisions only.

**10S-8. PLAYING FIELD**


- (a) The infield will be sixty (60) feet square.
- (b) The distance between all bases will be sixty (60) feet.

- (c) The distance between the point of home plate and the front side of the pitching rubber will be forty-two feet (42') in Girls 6U T-Ball, and thirty-five (35') feet in Girls 8U Coach Pitch, and Girls 10U.
- (d) The distance between the point of home plate and the front side of pitching rubber will be forty (40') feet in Girls 12U.
- (e) The distance between the point of home plate and the front side of pitching rubber will be forty three (43') feet in Girls 15U.
- (f) The distance from home plate to second base and from first base to third base will be eighty-four feet, ten inches (84' 10").
- (g) The distance from home plate to the nearest fence or other obstruction on fair ground shall be no less than one hundred eighty feet (180') in Girls 6U T-Ball through Girls 15U and no less than one hundred eighty-five feet (185') for High School Eligible.
- (h) The pitching rubber, home plate, and bases shall be standard dimensions in accordance with Official USA Softball Rules.

## OFFICIAL RULES

### 100. GIRLS 6U T-BALL SOFTBALL DIVISION

#### 100-1. PLAYING FIELD

- (a) An arc measuring ten (10) feet from the point at the back of home plate, from base line to base line, in front of the plate will be marked. This arc will be used to determine a legal fair ball when hit from the batting tee.
- (b) A pitcher's rubber will be placed at 42' from the point at the back of home plate to the front edge of the pitching rubber.
- (c) The batting tee will be positioned by the umpire near center point of home plate.
- (d) Base lines shall have marks at halfway points between home and first (for fielder position reference), first and second bases, between second and third bases, and between third and home plate.

#### 101-2. AGE ELIGIBILITY RULES

- (a) Girls 6U T-Ball will be six (6) and under. TTAS (Softball) playing age will be the age of the player as of August 31st of the previous year
- (b) Players whose age is seven (7) on August 31<sup>st</sup> previous year will not be allowed to participate

#### 102-3. TEAM EQUIPMENT

- (a) Only 2 1/4" diameter approved USA Softball or USSSA Softball approved bats may be used. Big barrel bats are not allowed in Girls T-Ball.
- (b) The batting tee will be of the adjustable type for normal strike zone. Umpire's decision will be final in determining proper adjustments within the strike zone.
- (c) Catchers must wear a helmet with a protective mask. Chest protector and shin guards are optional.

#### 103-4. LENGTH OF GAME

- (a) The length of game will be 5 innings or required time limit.

- (b) When a team scores a maximum of seven runs or makes three outs in one inning, the team then will go on defense.
- (c) Three (3) innings shall be considered a complete game if play is discontinued because of rain, darkness, or other causes, which make further play impossible.
- (d) A 15-run lead shall be considered a complete game, after three complete innings of play or an 8-run lead after four complete innings of play.
- (e) In case of a “runaway” ball game before the three (3) innings are completed, the manager of the team that is being subjected to the loss may choose to call the game by advising the chief umpire. Once the game is terminated, the decision cannot be revoked. The final score will be the score when the game was terminated.

**100-5. BATTER STRIKE-OUTS**

- (a) Batter is out when she has three (3) strikes. The ball is dead and base runners may not advance.
- (b) If the ball stops inside the ten foot arc and is not moving, any defensive player or batter may pick up the ball and hand it to the umpire without the batter being awarded first base or being called out.
- (c) If batter swings bat past hitting tee, it will be considered a strike.
- (d) If batter strikes the tee only, it will be considered a strike.
- (e) It will be called a strike if the ball is hit, but does not go out of the ten (10) foot arc. If the ball is fouled out of the ten-foot arc, it is a foul ball and not an out. If the batter interferes with the ball while the ball is in motion inside the ten foot arc, the batter will be called out for interference.
- (f) Number of practice swings allowable for each batter shall not exceed three. The fourth practice swing shall be called a strike. If the bat touches the ball on a practice swing and if the ball does not fall from the tee, it shall not be called a strike, unless it is the 4th practice swing.

**100-6. BASE RUNNERS**

- (a) When the umpire has the ball on the tee and the catcher is in the catcher's position, base runners shall not leave their bases until the ball has been hit. If a base runner leaves base before the batter hits the ball foul, the base runner must be returned to the base occupied. The ball is dead and no runner may score, nor runners advance. If the batter hits the ball fairly, the base runner leaving base before the batter hits the ball will be declared out. The ball is live and in play, unless with 2 outs, inning will be complete and no runners may score.
- (b) Runners may not advance if ball is not hit outside of the ten foot arc. (Exception: Runners may advance when forced to advance because of batter being awarded first base due to ball being fielded inside the 10 foot arc by opposing player while the ball is still in motion.

**100-7. CONTROL OF PLAYING ACTION**

- (a) To start play the umpire will place the ball on hitting tee and call "Batter Up".
- (b) Umpires will call "time" after every play and declare a ball dead. Time shall be called as soon as the lead runner is stopped from advancing by a defensive player. In TTA tournament play, "half-way" marks will be used. If trail runner/s have advanced past the halfway mark in the base line, they may continue to the next base; otherwise, runner must return to the previous base.
- (c) There is no intentional walk.

**100-8. OFFICIAL TEAM LINEUP**

T-Ball divisions may (optional) play with 10 in the batting lineup with the 10<sup>th</sup> player being either a 4<sup>th</sup> outfielder or play with 9 in the field with an EH (extra hitter)

**100-9. GENERAL RULES APPLICABLE TO GIRLS 6U  
T-BALL SOFTBALL**

- (a) The ball must be hit from the batting tee by the batter to be a fair ball.
- (b) Pitcher and catcher must be in their proper position at the time the ball is hit.
- (c) All defensive infield players must remain behind the thirty (30) foot halfway line until the ball is hit.

- (d) All outfield player positions must be behind the base line until the ball is hit.
- (e) The pitcher must remain in contact with the pitching rubber until the ball is hit. Continued violation shall be removal of the pitcher from the pitching position.

**Penalty for (c), (d) & (e)**

- If the ball is not hit fair or in play, move the defensive player(s) back to their correct position and tell them not to move forward before the ball is hit.
  - If the ball is hit fair and in play, and the player in violation makes the initial play on the ball, let the play continue and once the play has stopped, the umpire will put runner(s) in the position, in his opinion, the runner(s) would have reached if the violation would not have occurred.
  - If the ball is hit fair and in play, and the player in violation does not make the initial play on the ball, the play is live, and no penalty will be enforced.
  - In addition to the above penalties, give the defensive coach a warning. If the violation continues after warning the coach, the coach may be ejected.
- (f) The ball must be hit out of the ten (10) foot arc to be fielded and for runners to advance.
  - (g) If an opposing player fields a ball from within the ten-foot arc that is rolling, the batter will be awarded first base.
  - (h) If the ball is thrown out of playing field, each runner is allowed one base.
  - (i) As long as the ball remains inside the playing field, the base runner may continue to run until the lead runner is stopped.
  - (j) Bunting is not permitted. Full swing must be taken, or shall be called out and ball is dead.
  - (k) Infield fly rule is not in effect in Girls 6U T-Ball.
  - (l) Pitcher may return to the mound unless removed for excessive conferences or failure to stay in contact with the pitching rubber until ball is hit.
  - (m) If a fly ball is caught by any fielder, all runners must tag up. Any runner that did not tag up must return to the base. If runners have tagged up properly, they may advance. If the lead runner did not tag up, and trailing runners did tag up, the lead runner determines if runners return to their bases.
  - (n) Refer to Section 10 for additional applicable General Rules.

## OFFICIAL RULES

### 110. GIRLS 8U COACH PITCH DIVISION

#### 110-1. AGE ELIGIBILITY RULES

- (a) Girls 8U Coach Pitch Division ages will be eight (8) years of age and under. TTAS (Softball) playing age will be the age of the player as of August 31st of the previous year.
- (b) Players whose age is nine (9) on August 31<sup>st</sup> of the previous year will not be allowed to participate.

#### 110-2. LENGTH OF GAME

- (a) The length of the game will be six (6) innings or required time limit.
- (b) Three and one-half (3-1/2) or four (4) innings shall be considered a complete game if play is discontinued because of rain, darkness, or other cause.
- (c) A game is a complete game after 3 1/2 or 4 innings with a 15 run lead or after 5 innings with an 8 run lead.

#### 110-3. GENERAL RULES APPLICABLE TO GIRLS 8U COACH PITCH DIVISION

- (a) A maximum of 7 runs or 3 outs is allowed per inning.
- (b) All runners must remain on base.
  - If a base runner/s leave the base prior to the ball leaving the pitcher's hand, the ball will be called dead immediately and runner/s (in violation) will be declared out.
  - If a base runner/s leave the base legally and the ball is not hit fair, the ball becomes dead and all runners will be returned to the base previously occupied at the time of pitch. All pitches will count as ball or strike.
- (c) No dropped third strike rule.
- (d) No stealing.
- (e) There are no walks or "base on balls", intentional or otherwise.
- (f) No bunting is allowed. Full swing must be taken.  
**PENALTY:** Batter attempting to bunt, ball is dead, batter is out, no runner/s may advance.

- (g) Umpires will call “time” after every play and declare a ball dead. Time shall be called as soon as the lead runner is stopped from advancing by a defensive player. In TTA tournament play, “half-way” marks will be used. If trail runner/s have advanced past the halfway mark in the base line, they may continue to the next base; otherwise, runner must return to the previous base.
- (h) The Infield Fly Rule does not apply in Girls Coach Pitch.
- (i) The distance of the pitching rubber is 35 feet from the point of home plate to the front edge of the pitcher’s rubber.
- (j) The defensive player listed as pitcher must remain within four (4) feet beside or behind the pitching rubber until the ball has been hit.
- (k) Pitcher may return to the pitching position unless removed for penalty.
- (l) A batter will receive a maximum of five pitches or three swinging strikes, whichever occurs first. If the fifth pitch or subsequent pitch is hit foul, the batter will remain at bat as long as they continue to foul the pitch.
- (m) If the batted ball hits the Pitching Coach, the umpire will judge if the Pitching Coach made a legitimate attempt to get out of the way, the ball becomes dead. All runners advance one base. Batter is awarded first base. If the umpire rules that the Pitching Coach did not make the attempt to get out of the way, then the batter is declared out. No runner shall advance.
- (n) The Pitching Coach must be standing and keep one foot on or straddle the pitching rubber
- (o) Pitching must be an underhand motion. The pitching coach is allowed to verbally position the batter. The Pitching coach will not be allowed to communicate with any other player, Coach, or umpire while in the Pitching position while on offense either verbally or physically.
  - **(PENALTY: Removal of the Pitching Coach)**
  - Once the ball has been hit, the Pitching Coach must position himself/herself as not to be an obstruction to the defensive team on any play at all.
- (p) The catcher must be in the squat position in the catcher box and ready to receive the pitch.
- (q) The Pitching Coach cannot coach while his team is on offense.

## OFFICIAL RULES

### 120. GIRLS 10U DIVISION

#### 120-1. AGE ELIGIBILITY RULES

- (a) Girls 10U Division ages will be ten (10) years of age and under. TTAS (Softball) playing age will be the age of the player as of August 31st of the previous year
- (b) Players whose age is eleven (11) on August 31<sup>st</sup> previous year will not be allowed to participate

#### 120-2. LENGTH OF GAME

- (a) The length of the game will be six (6) innings or required time limit.
- (b) Three and one-half (3-1/2) or four (4) innings shall be considered a complete game if play is discontinued because of rain, darkness, or other cause.
- (c) A run lead of fifteen (15) after two and one half (2 ½) or three (3) innings or ten (10) after three and one half (3½) or four (4) innings will be considered a complete game.

#### 120-3. BATTER STRIKE-OUTS

Refer to Official USA Softball Fast Pitch JO Rule.  
(New to 10U - Dropped 3<sup>rd</sup> Strike Rule is in effect)

#### 120-4. PITCHING RULES

#### 120-5. BASE RUNNERS

## OFFICIAL RULES

### 130. GIRLS 12U DIVISION

#### 130-1. AGE ELIGIBILITY RULES

- (a) Girls 12U Division ages will be twelve (12) and under. TTAS (Softball) playing age will be the age of the player as of August 31st of the previous year.
- (b) Players whose age is thirteen (13) on August 31<sup>st</sup> of the previous year will not be allowed to participate

#### 130-2. LENGTH OF GAME

- (a) The length of the game will be six (6) innings or required time limit.
- (b) Three and one-half or four innings shall be considered a complete game if play is discontinued because of rain, darkness, or other cause.
- (c) A run lead of fifteen (15) after two and one half (2½) or three 3 innings or ten (10) after three and one half (3½) or four (4) innings will be considered a complete game.

#### 130-3. BATTER STRIKE-OUTS

Refer to Official USA Softball Fast Pitch JO Rule.

#### 130-4. PITCHING RULES

Refer to Official USA Softball Fast Pitch JO Rule.

#### 130-5. BASE RUNNERS

Refer to Official USA Softball Fast Pitch JO Rule.

## OFFICIAL RULES

### 140. GIRLS 15U DIVISION

#### 140-1. AGE ELIGIBILITY RULES

- (a) Girls 15U Division ages will be (15) and under. TTAS (Softball) playing age will be the age of the player as of August 31st of the previous year.
- (b) Players whose age is sixteen (16) on August 31st of the previous year will not be allowed to participate.

#### 140-2. LENGTH OF GAME

- (a) The length of the game will be seven (7) innings or required time limit.
- (b) Four and one-half or five innings of play will be considered a complete game if play is discontinued because of rain, darkness, or other causes, which make further play impossible.
- (c) A run lead of fifteen (15) after three and one half (3½) or four (4) innings or ten (10) after four and one half (4½) or five (5) innings will be considered a complete game.

#### 140-3. BATTER STRIKE-OUTS

Refer to Official USA Softball Fast Pitch JO Rule.

#### 140-4. PITCHING RULES

Refer to Official USA Softball Fast Pitch JO Rule.

#### 140-5. BASE RUNNERS

Refer to Official USA Softball Fast Pitch JO Rule.

#### 140-6. TEAM EQUIPMENT

METAL SPIKES OR METAL CLEATS ARE PERMISSIBLE IN GIRLS 15U AND HIGH SCHOOL ELIGIBLE GIRLS DIVISION ONLY. **NO METAL CLEATS OR SPIKES ARE ALLOWED ON TURF FIELDS IN ANY AGE DIVISION.**

#### 140-7. ELIGIBILITY TO PLAY IN OTHER TTA LEAGUES

Players who are registered in the Girls 15U Division are allowed to play on a Girls High School Eligible Division team. Refer to High School Eligible Rules.

## OFFICIAL RULES

ALL LEAGUE PLAY IN HIGH SCHOOL ELIGIBLE DIVISIONS SHALL BE GOVERNED BY THE NFHS (NATIONAL FEDERATION OF STATE HIGH SCHOOL) RULES WITH THE FOLLOWING EXCEPTIONS:

### 150. HIGH SCHOOL ELIGIBLE GIRLS DIVISION

#### 150-1. AGE ELIGIBILITY RULES

To participate in TTA High School Eligible leagues, players must be eligible to play in the following year on a high school team.

#### 150-2. TEAM EQUIPMENT

- (a) NFHS approved equipment including softballs, bats, uniforms, gloves, bases, and pitcher and home plates will be used.
- (b) Catchers must wear protective helmet with ear protection, chest protectors and shin guards.
- (c) Helmets will be required. See Section 10S-6(c) (face masks only).
- (d) METAL SPIKES OR METAL CLEATS ARE PERMISSIBLE IN GIRLS 15U AND HIGH SCHOOL ELIGIBLE GIRLS DIVISION ONLY. **NO METAL CLEATS OR SPIKES ARE ALLOWED ON TURF FIELDS IN ANY AGE DIVISION.**

#### 150-3. LENGTH OF GAME

- (a) The length of the game will be seven (7) innings or required time limit.
- (b) Four and one-half or five innings of play will be considered a complete game if play is discontinued because of rain, darkness, or other causes, which make further play impossible.
- (c) A run lead of fifteen (15) after three and one half (3½) or four (4) innings or ten (10) after four and one half (4½) or five (5) innings will be considered a complete game.

#### 150-4. BATTER STRIKE-OUTS

Refer to NFHS (National Federation of State High School) rules.

**150-5. PITCHING RULES**

- (a) ANY person under the age of 18 years, warming up a pitcher in any position, whether sitting or standing, will wear a facemask. NO LEAGUE OR TOWN CAN WAIVE THIS RULE. First offense – removal of coach from the game; Second offense – forfeit the game.
- (b) Refer to NFHS (National Federation of State High School) rules

**150-6. BASE RUNNERS**

Refer to NFHS (National Federation of State High School) rules.

**150-7. ELIGIBILITY IN OTHER TTA LEAGUES**

Players who are registered on a High School Eligible Team are allowed to play on a Girls 15U Division Team. Refer to Girls 15U Rules.

**TEXAS TEENAGE BASEBALL & SOFTBALL  
ASSOCIATION TOURNAMENT RULES**

**200-1. ELIGIBLE LEAGUES**

To be eligible for tournament play, a league must be an affiliated member league of the State Association by the due date of each year and must have complied fully with all standard rules and regulations for regular League Play.

**200-2. ELIGIBLE TEAMS**

- (a) To be eligible for tournament play, a team must be certified by their league and must have completed their regular season schedule of a minimum of ten (10) games by the official end of the season as stated on page 6, Section B-3. All TTA teams are required to send their first, second and if needed, third place teams, as determined by the State Board to District Tournament play. In case of an approved three team league, only the first place team will attend District Tournament and may pick up players from the other two teams. Local leagues may substitute a team for the 1st, 2nd or 3rd place team that is unable to attend a District Tournament, the team replacing will assume the place position of the team they replaced. The replaced teams players will not be available for pickup per the rules listed in the pickup player process in this section. Penalty for non-participation can be up to a one year suspension from TTA for that particular league and/or manager. The affiliate will also receive a non-participation fine.
- (b) Any post season team, referenced in Eligible Teams (a), that does not attend their assigned tournament, the players from those teams are not eligible to be picked up. At any point during season play, where a team is locked into a post season position, and declares non post season participation, even before the season is complete and rosters have been entered, this rule will apply where the team's players become ineligible.
- (c) STATE ASSIGNMENT: All TTAB and TTAS will send 1st place teams in district to state. Selected divisions will advance 1st, 2nd and 3rd place teams at the discretion of the State Board at its annual Tournament Allocation Meeting.

- (d) To keep the integrity of TTAB/TTAS tournaments, any team that qualified for post season tournament play and/or fails to show or leaves a tournament before completion, will be subject to a fine.
- (e) It is the manager's/coach's responsibility to contact the appropriate officials and **TTA State Office by email in writing**, seven (7) days prior to the coaches meeting if their team is unable to attend their tournament. Failure to contact seven (7) days prior, will be subject to a fine.
- (f) Any team leaving a tournament before tournament completion without notification, will be ineligible to advance play and is subject to a fine.
- (g) Any fines will be assessed to the affiliate. Affiliate is responsible for these fines and should remit payment to the State Office.

**200-3. CERTIFICATION OF TEAM**

- (a) Immediately at the end of the Official League Season, or at the earliest possible date after a team has clinched a tournament spot, the League Officials must register their League Teams, including the three (3) pick-up players permitted for tournament play, with the State Office.
  - The Tournament Roster, with pick-up players, must be submitted to State Office by the date on the Official TTA calendar by noon (12:00pm) in order for the league champion to be certified for District Tournament play. **Penalty for late submission will be up to a 2 game suspension for the head coach.**
- (b) Penalty for non-participation in post season play, is subject to, up to a one-year suspension from TTAB/TTAS for that particular affiliate town, and/or manager. The affiliate will also receive a non-participation fine. An exception to this penalty is a written notice by email, 7 days prior to the tournament starting, to the State Office advising that a team in your organization will not be able to participate in tournament play and giving acceptable reason for non-participation.
- (c) If a legal roster player is not present at the start of the game, thus not listed on the lineup card or the books, and shows up after the game has started, that player(s) may be added to the lineup without penalty. During tournament play: any player added to the lineup after the game starts will fall under participation rule 200-5.

- (d) All managers participating in District and/or State Tournament play must present to the Tournament Director a copy of the medical insurance declaration page, Texas Teenage requires that birth certificates be the official birth certificate, passport or official military dependent I.D. as documented proof of the correct date of birth. State issued identification cards, foreign birth certificates and/or government resident alien documentation is acceptable so long as proof of the correct date of birth is validated on such documentation, (a photostat copy thereof) of each player on their respective teams, including up to three (3) extra “pick-up” players. Players age sixteen (16) or older may be required to show a valid (picture) driver’s license. Tournament Directors must check each certificate.
- (e) Under no circumstances will a player be permitted to play in the tournament without one of the above documents.
- (f) Any identification document presented to the Tournament Director that is altered in any way prohibits the player from playing in that tournament.

**200-4. TOURNAMENT TEAM ROSTER**

- (a) A team will not have more than eighteen (18) registered and certified players on its roster. (Including three (3) pick-up players)
- (b) In TTAB/TTAS, no tournament team will have more than eleven (11) players the maximum age in their division.
- (c) The line-up shall contain the first and last name, defensive position and uniform number of all players. All available substitutes should be listed in the designated place by their first and last name and uniform number. Lineup cards are required to be presented to the official books and the plate umpire before the game begins.
- (d) Coaches must report all line up card changes to the home plate umpire, who will then report changes to the official books.
  - PENALTY
    - First offense – warning to the team.
    - Second offense – head coach and the unreported player will be restricted to the bench for the remainder of the game.

- (e) All boundary line protests must be settled before the TTA end of season date. No TTA tournament will allow protests over boundary line issues. All protests over the legality of a tournament team roster/player must be made immediately to the Tournament Director and then presented to the area TTA State President immediately for ruling. If a protest is made during a game based on the legality of a tournament team roster/player, the game will continue under protest pending the ruling from the TTA State President.

**200-5. PLAYER PARTICIPATION – DISTRICT & STATE**

Every player attending the tournament must play in one of the players first two (2) games in every post season tournament.

- (a) Option 1 – Play 3 consecutive outs in the field in the same inning.
- (b) Option 2 – Complete one at bat, whereas the batter becomes a batter/runner or is put out.

**PENALTIES:**

- 1) Any coach that violates this rule, the Head Coach will be suspended for the remainder of the tournament.
- 2) The second game that the player/s did not play in if the game is won, is now a forfeit.
- 3) If the game was lost or forfeited, the player in question must play in the next game they attend.

**200-6. PICK-UP PLAYER PROCESS**

- All Affiliates will be required to name affiliate player agent(s) to assist in the pickup player process. Coach's advancing to the post season will submit the player names, parent names and phone numbers of up to 6 players they wish to be contacted for pickup availability to their local league president. The local league president will then submit the player list for each team advancing to the affiliate assigned player agent.

Girls coach's list will be submitted by the last Wednesday of the girls regular season as per the current TTA calendar. Boys coach's list will be submitted by the last Wednesday of the boy's regular season as per the current TTA calendar. Once the list is submitted, the list will be turned over to the player agent(s), the player agent(s) will contact the parents in order, per the coach's list to verify availability to play and agreement or rejection on being selected as a pickup player. If a player is unavailable or declines to be picked up for one team, that player will become ineligible for any team. Calls will be made in the following order. First place team first, then second place team, and alternate picks until each team has their desired number of pick up players, up to 3 total. If a pickup player is unavailable or declines to play, the same team will get one more call prior to switching to the next team.

If both players decline or are not available, that team will lose their pick for that round and get to make this pick up at the end. This process needs to be completed by Saturday prior to the roster deadline per the current TTA calendar. Once the players have been determined for each team, the player agent(s) will notify the coaches of their pickup players.

- Playoff rosters must be submitted on Sunday by noon, per the current TTA calendar.

**Penalty as listed under 200-3 Certification of Team.**

- Any team that does not submit their list to the league president by the Wednesday deadline listed previously, will forfeit their right to pickup players.
- All teams qualifying for post season play can select up to 3 pickup players for tournament play. Pickup players will only be allowed to be selected from teams that played within their same league (7 or less teams) or division on split leagues (8 or more teams, for example: North Division, South Division) during the regular season.
- They must be eligible players of the League in accordance with Official TTAB/TTAS Rules and Regulations, and must be from a team eligible for pickup. Any team that drops eligibility from advancing to the post season, those players will not be available for pickup, per 200-2 Eligible Teams (b).

- All pickup players may be of the maximum age provided for in the division in which they are playing.
- Pickup players will not be added following the tournament roster deadline.

**200-7. UNIFORMS**

- (a) T-Shirts and short or jeans may be worn in lieu of uniform. T-Shirts or jersey must be similar in color.
- (b) Numbers will be required on uniforms for all tournament play.
- (c) Pick-up players will be permitted to participate in either their regular season uniform or the uniform of the team with which they will participate.

**200-8. PLAYING FIELDS**

- (a) All tournament games will be played on fields as required and specified in the official TTAB/TTAS Rules and Regulations.
- (b) Official TTAB approved baseballs and TTAS approved softballs are required in Texas Teenage Association tournament play. The use of the TTA approved baseball/softball will be allowed as stated in the Tournament Guidelines.
- (c) A flat surface is required in all TTAS tournaments. No pitching mounds.
- (d) In TTAS (softball) tournament play, the use of the white/orange double base at first base is mandatory.
- (e) In T-Ball divisions, the same type of batting T must be used on all fields.
- (f) Portable mounds will be allowed in TTAB tournaments, only if the mound has been approved by the area's State Director. The pitcher's mound shall be raised by a gradual slope to a height of six (6) inches to ten (10) inches above the home plate and base line level. At each tournament location, all pitching mounds used in TTAB tournaments, must be the same height.

#### **200-9. PLAYING RULES**

Official TTA Rules and Regulations shall supersede all Ground Rules and/or Special Rules adopted by local affiliates for local league play. All tournament play will be in accordance with TTA Rules and Regulations.

**BASE RUNNERS.** A base runner is out, if in the judgement of the umpire, the base coach at first or third base, touches or holds the runner (physically assists) him/her in returning to or leaving first or third base. (Giving a runner a high-five after a home run is not assisting him in any way)

#### **200-10 SHORT HANDED RULE**

- (a) If a team begins play with the required number of players, 9 or 10, they can continue with one or two less players. Whenever a player(s) leaves the game for any reason other than ejection. Under no circumstance will a team be permitted to bat less than eight.

**PENALTY:** The game is forfeited for any violation.

- (b) When the player(s) who has left the game is scheduled to bat, an out will be declared for each turn at bat. The player who has left the game cannot return to the lineup. Exception: A player who has left the game under the blood rule, may return even after missing a turn at bat.
- (c) If a player leaves the game as a runner, player will be declared out.

#### **200-11. TTAB PITCHING RULES**

- (a) See applicable age division for pitch limits and days of rest.
- (b) It is the head coaches responsibility to ensure no pitch violations occur for their team, there will be no deviation from the penalties for pitch count violations.
- (c) During all TTAB tournaments total pitches per tournament will apply as follows; Boys 10U may not exceed 150 pitches. Boys 12U may not exceed 170 pitches. Boys 14U may not exceed 190 pitches. **EXCEPTION: A pitcher may finish the batter.**
- (d) If a pitcher is removed from the mound, or lineup, during a game, he may not return to the mound as a pitcher during the game.

- (e) **PITCH COUNT PENALTIES**, violation of any of these pitching rules will result in:
- Removal of the player from the mound and ejection of the Head Coach for the remainder of that game plus Head Coach from the next scheduled game.
  - Second violation is removal of the Head Coach for the remainder of the tournament.
  - If a pitcher pitches during their required days of rest, that game will be a forfeit. See rule 10B-3.

**200-12. DOUBLE ELIMINATION TOURNAMENTS**

- (a) All District Tournaments will be double elimination.  
(b) All State Tournament Play will be double elimination. Exception in High School Eligible.

**200-13. TOURNAMENT DIRECTORS**

- (a) A Tournament Director should be selected at the time the Tournament Request form is submitted to the State Office. The Tournament Director selected will not manage nor coach a team participating in the tournament or umpire. After an organization has been notified by the State Office of being selected to host a tournament, the Tournament Director should immediately be confirmed, forwarding to the State Office the name, address, and telephone number(s).
- (b) Tournament Directors must check all tournament rosters and required documentation (including all birth certificates and insurance documents) at the coaches meeting. (Teams or Zoom) All such documents must be emailed or hand delivered, with enough time allowed to properly check the documents prior to the tournament beginning. Any data entry mistakes discovered must be reported to the area State Director and TTA State Office.
- (c) It is the Tournament Director's responsibility to verify the player participation rule is followed and penalties are enforced as stated in rule 200-5.
- (d) Tournament Directors will be furnished a copy of State approved Special Rules and Tournament Brackets by the State Office.

- (e) Local ground rules shall be submitted by Tournament Directors to team managers and umpires prior to the first tournament game. Ground rules apply to playing field conditions only.
- (f) Failure of an organization or Tournament Director's compliance of TTAB/TTAS Rules and Regulations, Special Rules, Brackets, etc. will affect future allocation of tournaments.
- (g) All District & State Tournament Directors must notify the State Office, within 24 hours, with the first and second place teams, with managers' names and contact information.

**200-14. STATE APPROVED SPECIAL RULES**

- (a) All TTAB/TTAS District and State Tournament Championship games will use the designated number of innings except applicable run rules shall apply as appropriate (see specific division rules).
- (b) Coin flip for home team will occur prior to every game, including the championship and the if needed championship game
- (c) Time Limits District & State Tournaments
  - All Girls – 1 hr 30 min
  - Boys 6U, 8U, 10U & 12U – 1 hr 30 min
  - Boys 14U – 2 hr
- (d) No time limit will be enforced in championship game(s)
- (e) No International Tie Breaker
- (f) Tie breaker rule for district and state tournaments will be as follows: If the game is tied at the end of regulation innings or tied after time expires, each subsequent half inning each team will begin their half inning with one out until a winner is declared.
- (g) TTA prohibits any District Tournament to charge a daily gate fee that exceeds \$6.00 per adult and \$4.00 per student (18 years and under) and senior citizens (65 years and older). State Tournament may not exceed \$7.00 per adult and \$4.00 per student and senior citizen. A State Director may approve a team fee in lieu of a daily gate fee for tournaments.

#### **200-15. WEATHER GUIDELINES & SUSPENDED GAMES**

- (a) All Associations are required to have a working lightning detector at District and State Tournaments.
- (b) When thunder is heard or lightning is seen, the leading edge of the thunderstorm is close enough to strike your location with lightning. Suspend play for at least 30 minutes and vacate the outdoor activity to the previously designated safer location immediately.
- (c) 30 minute rule. Once play has been suspended, wait at least 30 minutes after the last thunder is heard or lightning is witnessed prior to resuming play.
- (d) Any subsequent thunder or lightning after the beginning of the 30-minute count will reset the clock and another 30-minute count should begin.
- (e) When lightning detection devices or mobile phone apps are available, this technology could be used to assist in making a decision to suspend play if a lightning strike is noted to be within 10 miles of the event location. However, you should never depend on the reliability of these devices and, thus, hearing thunder or seeing lightning should always take precedence over information from a mobile app or lightning-detection device.

#### **Suspended Games – Tournament Games Only**

1. All tournament games will be completed in their entirety by total number of innings allotted for a complete game per age division.  
Exceptions:
  - a. Run Rule
  - b. Time Limit
2. If a game is unable to be completed due to weather or other factors, that game will be suspended to be resumed in progress at the earliest available opportunity.
3. Tournament Director must notify the area State Director of any games postponed due to a weather delay. The tournament host will not end the game early due to weather without the approval of State Tournament Committee (State Board of Directors).
4. Any special accommodations or deviations to the tournament brackets or determining a winner where games cannot be played, must have approval from the State Board and Tournament Committee.

#### **200-16. WALK UP MUSIC POLICY**

Teams and players are permitted to use walk-up music during their at-bats provided that all music selections comply with the following guidelines

- Music must be free of profanity, sexually explicit content, discriminatory language, and any material deemed inappropriate by tournament officials.
- Walk-up songs must not exceed 15 seconds in duration.
- Music must stop when the batter steps into the batter's box.
- Volume must be kept at a reasonable level to ensure it does not interfere with gameplay or communication between officials and teams.

##### **Violation Penalty:**

- First Offense: Verbal warning issued to the team manager and offending player.
- Second Offense: Loss of walk-up music privileges for the entire team for the remainder of the game.
- Third Offense: Walk-up music privileges revoked for the entire team for the remainder of the tournament. Further violations could result in game forfeiture and/or additional disciplinary actions at the discretion of the tournament director.

**Tournament officials and umpires on the field reserve the right to bypass warnings and escalate penalties in the case of flagrant or intentional violations.**

#### **200-17. TOURNAMENT BRACKETS AND DATES OF TOURNAMENTS**

- (a) Official TTAB/TTAS tournament brackets shall be provided to all tournament directors and this bracket will be followed. Deviations due to unforeseen circumstances must have the approval of area State Director, TTA Tournament Chairman and TTA President and TTA Vice President(s).
- (b) All games must be played as indicated on the bracket.  
**PENALTY:** Coach will be suspended for the first two games of the State Tournament
- (c) All towns hosting a District or State Tournament must have the Official Bracket posted at all times, with teams, date, time and place for all games. In boys' tournaments, pitcher pitch count total for tournament and if they are in days rest must be posted.

- (d) BASEBALL ONLY (Excluding Boys 6U T-Ball, Boys 8U Coach Pitch) UNDER NO CIRCUMSTANCES shall a team be required to play more than three (3) games within any tournament day.
- (e) Tournament brackets will be furnished by the State Office. Tournament officials should also take necessary steps to ensure that two teams from the same league do not match up in the first round.
- (f) All District and State tournaments will be played within the weeks designated on the Official TTAB/TTAS State calendar.
- (g) All District and State Tournaments must be scheduled to begin on Monday of the designated tournament week, played in consecutive days. Deviations to unforeseen circumstances must have the approval of the area State Director, TTA Tournament Chairman, The TTA President and TTA Vice President.
- (h) In boys and girls High School Eligible, tournaments shall be set on weekends and will be published on the Official TTA calendar.
- (i) All District Tournament Brackets with game times and dates must be approved by the State Director serving the tournament location. All State Tournament Brackets with game times and dates must be approved by the State Director and the State Tournament Committee.

#### **200-18. TOURNAMENT BRACKET DRAW**

Tournament Directors will use these steps to draw for their tournaments:

##### **Bracket Draw for tournaments with no byes:**

- 1) If there are 2 columns of first round games, draw and fill all second column games first, then once all second column games have been filled, then continue with filling the first column games with remaining teams per the instructions below.
- 2) Place all 1st place teams in a hat. Starting at the top of the bracket, draw and fill a 1st place team on the top line of the first game. Then alternate to the bottom of the bracket, draw and fill 1st place team on the top line of the last game in the first round. Continue alternating from the top of the bracket, to the bottom, skipping to the next game until all 1st place teams have been selected.

- 3) If there are any 3rd place teams, draw them next. Start at the top of the bracket, draw for the bottom line. Then drop to the bottom of the bracket, draw for bottom line. Continue alternating top to bottom until all 3rd place teams have been drawn. 3rd place teams will match up with the 1st place teams in the first round, where applicable. In some larger state tournaments, there may be 4th place teams, if this is the case, start with any 4th place teams, then work in the 3rd place teams.
- 4) Finish out the bracket by drawing 2nd place teams. Work down from the top of the bracket to the first empty line and draw. Then work up from the bottom of the bracket to the first empty line and draw. Continue this until all 2nd place teams are drawn to finish out the bracket.
- 5) When applicable, teams will not match up with a team from their same league in the first round in District tournament or same District tournament at the State Tournaments.

**Bracket Draw for tournaments with bye/s:**

- 1) Put all 1st place teams in a hat to draw for bye/s on the bracket. All byes will be drawn in number order.
- 2) If there are 2 columns of first round games, draw and fill all second column games first, then once all second column games have been filled, then continue with filling the first column games with remaining teams per the instructions below.
- 3) Put the remaining 1st place teams in a hat. Starting at the top of the bracket, work down to the first game that does not filter into a bye 2nd round opponent, draw and place 1st place team on the top line. Repeat starting at the bottom of the bracket, work up to the first game that does not filter into a bye 2nd round opponent, draw and place 1st place team on the top line. Continue alternating from the top of the bracket, to the bottom, skipping to the next game while repeating the steps listed, until all 1st place teams have been selected.

- 4) If there are any 3rd place teams, draw them next. Start at the top of the bracket, work down until you get to the first game with a 1st place team, draw a 3rd place team for the bottom line. Then drop to the bottom of the bracket, work up until you get to the first game with a 1st place team, draw a 3rd place team for the bottom line. 3rd place teams will match with 1st place teams in the first round. In some larger state tournaments, there may be 4th place teams, if this is the case, start with any 4th place teams, then work in the 3rd place teams following the steps listed.
- 5) Finish out the bracket by drawing 2nd place teams. Work down from the top of the bracket to the first empty line and draw. Then work up from the bottom of the bracket to the first empty line and draw. Continue this until all 2nd place teams are drawn to finish out the bracket.
- 6) When applicable, teams will not match up with a team from their same league in the first round in District tournament or same District tournament at the State Tournaments.

#### **200-19. TOURNAMENT ALLOCATION**

- (a) The TTA Board will allocate District Tournaments in a May Tournament Allocation Meeting each year. State Tournaments will be awarded at a January Tournament Allocations meeting.
- (b) Tournament requests should be submitted, along with tournament director's name, address, and phone number, to the State Office before May 1<sup>st</sup> for District Tournaments and January 15<sup>th</sup> for State Tournaments.
- (c) All qualifying teams within the same area, and especially within the same organization, will be assigned to the same district to determine State Tournament participant(s).
- (d) State tournament host, the winner and in some cases, second place teams, of each league at the discretion of the State Board of Directors, will receive a bye to the state tournament.
- (e) TTA State Directors reserve the right to change this rule if they deem necessary.

#### **200-20. QUALIFICATIONS, PROTESTS, AND DISPUTES**

- (a) Any violation of Tournament Rules must be reported immediately to the Tournament Director.

- (b) It will be the duty and responsibility of the State President to rule on the qualifications and eligibility of all active member leagues during and before the end of the regular season of League Play. Any ruling or decision made by the State President will be considered final.
- (c) The Tournament Officials shall decide all protests and disputes arising during Tournament Play on the level and at the time at which they occur. A Protest Committee must be available at all times. A Tournament Director will be able to serve as an official member of the Protest Committee. A protest which may arise from interpretation of playing rules, will be made by notifying the Umpire-In-Chief and the manager of the opposing team, at the time of occurrence and before the next legal pitch. The game clock will be paused while the tournament director determines if the protest will be allowed based on interpretation of playing rules. If the protest is allowed, the protest committee will review the protest and issue their ruling. The decision by the protest committee will be final and not subject to appeal. Once the protest is settled, the game will resume. Protest will not be allowed on umpire judgement calls, example: balls and strikes, fair or foul.

**200-21. UMPIRES FOR TTAB/TTAS TOURNAMENTS**

- (a) Umpires for District and State Tournament games must be 18 years of age or older and certified.
- (b) There must be at least two (2) Certified Umpires officiating all TTA District and State Tournament games.
- (c) Umpires must be selected by the host organization's Tournament Director. All umpires must be approved by the State Umpire Committee and the area State Director for all state tournaments.
- (d) Umpires must be chosen from the best source available in the immediate area for district tournaments.
- (e) Umpires must be proficient with TTAB/TTAS Rules and Regulations. Prior to tournament play, Tournament Directors shall furnish Umpires a TTAB/TTAS Rulebook.

- (f) Umpires must be dressed alike in official umpire attire and must wear the official TTA umpire hat for all District and State Tournament games.
- (g) A Tournament Director will not umpire any tournament game.
- (h) Umpires must check all bats and required equipment prior to each game in District and State Tournament play.
- (i) Umpires will ensure that all bats have correct stamp/stamps, free of cracks and damage, and the bat is not altered in any way. Choke-up knobs are not allowed. Ensure all batting helmets are free of cracks and damage. In all softball divisions ensure that the batting helmet has a face mask secured to the helmet correctly.
- (j) Umpires will initial in the official scorebook indicating that they have checked all equipment prior to the game.

**200-22. SCOREKEEPERS/STATISTICIANS**

The Affiliate will furnish a competent scorekeeper/statistician for each game to record and keep an accurate record of: at bats, errors, extra base hits, strikeouts, walks, pitch count, bases on balls, and stolen bases. **The pitch count statistician is required to stop play immediately and notify the umpire when the Pitcher has reached his pitch count maximum** In tournament play, The scorekeeper and statistician cannot be the same individual.

**The score keeper may only notify of an improper batter and replace with the proper batter before the first pitch is thrown or in T-Ball before the first swing is made in the at bat, with no penalty enforced.**

**200-23. OFFICIAL BASEBALL/SOFTBALL**

All towns hosting a Boys District or State Tournament must use the official TTAB approved baseball.

- Diamond DOL-1

All towns hosting a Girls District or State Tournament must use the official TTAS approved Softball.

- Dudley Thunder Heat

**200-24. OFFICIAL TTA AWARDS**

All District and State Tournaments will present the approved TTA awards to all first and second place managers or third and fourth places as in the following guidelines. Affiliates hosting a District or State tournament will be required to present individual player awards to the appropriate number of teams depending on number attending the tournament, exception: High School Eligible. The individual awards may be trophies, plaques or rings. All awards must be approved by the area State Director.

- 3<sup>rd</sup> Place - 8 inches in height
- 4<sup>th</sup> Place - 6 inches in height
- 1<sup>st</sup> - 4<sup>th</sup> place plaques (all 5" x 7")

State Trophy/Plaque Sizes

- 1<sup>st</sup> Place - 14 inches in height
- 2<sup>nd</sup> Place - 12 inches in height
- 3<sup>rd</sup> Place - 10 inches in height
- 4<sup>th</sup> Place - 8 inches in height
- 1<sup>st</sup> - 4<sup>th</sup> place plaques (all 6" x 8")

Guidelines for player awards will be included in all tournament guideline packages. These individual player awards will be furnished by the tournament host. All State tournament hosts will be required to furnish a player participation award to all players in age divisions 8 and under.
